STAFF RECOMMENDATION

COMES NOW the Staff of the Public Service Commission of the State of Missouri ("Staff") and respectfully states as follows:

- 1. On June 23, 2000, Laclede Gas Company ("Laclede") filed a Verified Application to issue First Mortgage Bonds, Unsecured Debt and Common Stock in an amount not to exceed \$350,000,000 with the Missouri Public Service Commission ("Commission").
- 2. On July 31, 2000, Staff filed a Recommendation and Memorandum regarding Laclede's Application. Staff recommended approval of Laclede's Application with two conditions.
- 3. On August 9, 2000, Laclede filed a Response to Staff Recommendation in which it stated that it had no objection to the two conditions recommended by Staff.
 - 4. On August 10, 2000, the Commission entered its Order Granting Application.

5. On August 15, 2000, Laclede filed a Request for Clarification in which it sought to have the Commission clarify its Order by adding language consistent with Section 393.200.1. The Staff has reviewed this language and agrees that it is appropriate language. Accordingly, Staff has no objection to Laclede's Request for Clarification.

WHEREFORE, Staff respectfully recommends that the Commission approve Laclede's Request for Clarification.
