Staff Recommendation for Approval of Tariff Sheets

1. On May 15, 2001, the Commission issued a Report and Order in this case, in which it approved a water service territorial agreement between the Missouri-American Water Company (Company) and the Public Water Supply District No. 2 of St. Charles County, Missouri (District).

2. As a part of its Report and Order, the Commission ordered the Company to file revised tariff sheets in compliance with the territorial agreement for Commission approval.

3. On June 25, 2001, the Company made a tariff filing in this case, which included both revised and new tariff sheets as were necessitated by the Commission's approval of the subject territorial agreement.

4. The Staff has reviewed the tariff sheets that the Company filed on June 25 and believes they are in compliance with the Commission's Report and Order and the subject territorial agreement. (The Staff would also note that the subject tariff sheets contain the same language as was presented in the example tariff sheets that the Company submitted with the Joint Application in this case.)

5. Based upon its review of the subject tariff sheets, the Staff recommends that the Commission issue its Order approving said tariff sheets to be effective for service rendered on

and after July 25, 2001, the proposed effective date of said sheets. More specifically, the Staff recommends approval of the following tariff sheets:
