Staff Recommendation to Approve Name Change and Proposed Replacement



On November 24, 1999, IXC Communications Services, Inc. (IXC), a competitive telecommunications company, filed a proposed replacement tariff which reflects IXC's corporate name change to BroadWing Communications Services, Inc. Included with the tariff filing is a copy of IXC's Amended Certificate of Authority from the Missouri Secretary of State. IXC provides interexchange telecommunications services under authority granted by this Commission to IXC Long Distance, Inc. (IXC-LD) in Case No. TA-95-387. IXC LD's name was changed to IXC Communications Services, Inc. in Case No. TO-99-61.

According to the cover letter, IXC made no other changes to the proposed replacement tariff other than change the corporate name. However, the proposed replacement tariff was incorrectly numbered and contained a typographical error. The tariff filing also removed text regarding deposits because the company no longer requires deposits from customers. At the request of the Telecommunications Department Staff (Staff), IXC submitted substitute tariff pages on December 10, 1999 to re-number the tariff and correct the typographical error. The Staff has no objections to the proposed tariff, as amended, and recommends the Commission issue an order to amend IXC's certificate of service authority to provide interexchange telecommunications services and approve the following tariff pages effective December 24, 1999

The Staff is aware of another filing that was filed in conjunction with this filing. On November 23, 1999, Eclipse Telecommunications, Inc. filed a tariff to change its name to BroadWing Telecommunications, Inc. (Case No. TO-2000-339, Tariff No. 000478). The Staff is also filing a recommendation to approve that proposed name change.
