On August 23, 2016, Taney County Regional Sewer District ("District") and Taney County Utilities Corporation ("TCUC") filed a joint application ("Application") with the Commission. The Application seeks authority for District to buy the assets TCUC uses to provide sewer service to approximately 51 customers in Taney County, and then for District to provide sewer service to those customers.

The Commission directed notice of the Application to be given, and set a deadline of September 7, 2016 for interested parties to intervene.

The Commission received no intervention requests. Thus, the Commission will order its Staff to file a Recommendation or alternative pleading.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a Recommendation or, in the alternative, a pleading stating when it plans to file its Recommendation, no later than October 11, 2016.

2. This order shall be effective when issued.
