On November 14, 2017, Jefferson County Public Sewer District and Utility Management of Missouri, LLC, as the court-appointed receiver of P.C.B., Inc. ("Applicants"), filed a joint application with the Missouri Public Service Commission ("Commission") seeking an order authorizing the sale, transfer, and assignment of assets relating to sewer services provided to customers in Jefferson County, Missouri.

On January 10, 2018, the Staff of the Commission filed a recommendation to approve the application subject to several conditions. The Commission will direct the Applicants to file a response addressing the conditions in the Staff recommendation and provide an opportunity for any other party to object or comment on the proposed conditions.

THE COMMISSION ORDERS THAT:

1. Jefferson County Public Sewer District and Utility Management of Missouri, LLC shall respond to the Staff recommendation, specifically addressing the conditions set out therein, no later than January 18, 2018.
2. Any other party wishing to respond to the proposed conditions in the Staff recommendation shall do so no later than January 18, 2018.
3. This order shall become effective when issued.
