#### APPLICATION FOR AUTHORITY TO TRANSFER ASSETS

COME NOW Navigator Telecommunications, LLC. ("Navigator" or "Seller") and Birch Telecom of Missouri, Inc., d/b/a Birch Communications ("Birch") (jointly "Applicants"), pursuant to Section 392.300 RSMo. 2000 and 4 CSR 240-3.520, hereby respectfully request Missouri Public Service Commission ("Commission") authority to effect an acquisition and transfer of certain assets currently owned by Navigator to Birch. Applicants seek such Commission authority to enable Birch to begin serving certain Navigator subscribers in Missouri immediately upon a grant of this Application (the "Application"). Navigator does not seek a transfer or cancellation of Navigator's Certificate of Service Authority. In support of this Application, Applicants state as follows:

#### II. DESCRIPTION OF APPLICANTS

2. Navigator is a limited liability company organized under the laws of the State of Arkansas and is duly authorized to do business in Missouri as a foreign limited liability company. A Certificate of Good Standing from the Missouri Secretary of State providing that Navigator is authorized to do business and in good standing in Missouri is attached hereto as **Exhibit A**. Navigator is a local exchange and non-dominant interexchange telecommunications service provider, which is certified, registered or otherwise authorized to provide local services in thirty-six states and long distance services in forty-seven states. Navigator was granted authority to provide local exchange services in Missouri in Dockets TA-200-232 and TA-98-383. Navigator seeks to transfer approximately 203 presubscribed residential customers and 42 presubscribed business customers of its services in Missouri to Birch.

- Birch is a corporation organized under the laws of the State of Delaware and is duly authorized to do business in Missouri as a foreign corporation. A Certificate of Good Standing from the Missouri Secretary of State providing that Birch is authorized to do business and in good standing in Missouri is attached hereto as **Exhibit B**. Birch is a subsidiary of Birch Telecom, Inc., a Delaware corporation ("Birch Telecom"). Birch adopted the fictitious name "Birch Communications" following the acquisition by Access Integrated Networks, Inc., a Georgia-based local exchange and long distance carrier ("Access"), of Birch Telecom. A copy of the Registration of Fictitious Name filed by Birch is attached hereto as **Exhibit C**. Birch Telecom and its affiliates are authorized to provide local and long distance services in twenty-six states. Birch was granted local exchange and long distance resale authority in Missouri in Dockets TA-97-371 and TA-97-372 and its Certificate is in good standing with the Commission. Birch's managerial, technical and financial ability to provide telecommunications services are a matter of record with the Commission; and Birch respectfully requests that the Commission take official notice of that information and incorporate it herein by
- 4. Navigator and Access entered into an Asset Purchase Agreement (the "Agreement") on June 1, 2008, whereby Access will obtain certain assets of the Seller, specifically Seller's current residential and business local exchange and long distance customers. Access will immediately drop the Missouri-based assets into Birch. This transaction is predicated on applicable regulatory approval. A copy of the Agreement is attached hereto as **Exhibit D**. A copy of Birch's balance sheet and income statement are attached hereto as **Exhibit E**.

reference. Birch is unaware of any pending customer complaints associated with its provision of service in

Missouri.

5. Under the terms of the Agreement, in exchange for consideration, Access will acquire from Navigator approximately 203 presubscribed residential customers and 42 presubscribed business customers located in Missouri, customer related data, databases, and customer records needed to support the provision of telecommunications services to Navigator subscribers. Access will immediately transfer these assets to Birch, which will provide telecommunications services as described in this Application. Navigator will continue to provide telecommunications services to all customers affected by this transaction pursuant to Navigator's existing tariff until this Application is granted by the Commission.

6. Upon the closing of the Agreement, Birch will assume all managerial, technical and financial responsibilities in connection with the operation of the retail local and interexchange long distance assets in order to provide telecommunications services to the affected Navigator customers in Missouri. Prompt handling of this notification will afford an expeditious, transparent and cost effective transition and will enable Birch and Navigator to remain fully compliant with their regulatory obligations. Navigator's customers affected by this transaction will continue to receive the same services from Birch under the current rates, terms and conditions as they currently enjoy. This transaction is being made in a seamless fashion that will cause no changes in customers' rates, terms and conditions of service and will be made at no charge to customer as they transition to Birch as their presubscribed carrier. There will be no interruption of service, other than a minor change to the non-regulated voicemail, and customers will be appropriately informed of their choices. The transfer of assets from Navigator to Birch will not result in any interruption or diminution in the quality of service provided to customers in Missouri and will be essentially transparent to such customers. Navigator's customers will be notified via letter that states (a) the quality of service to the customers will remain the same; (b) Birch will continue to provide service to the customers with the same or better services and rates currently provided to them by Navigator; (c) the customers have the right to switch to the carrier of their choice; (d) the customers may contact either Birch or Navigator via a toll free number with any questions regarding the switchover; and (e) the information required by 4 CSR 240-3.520(2)(G).

7. Written notice of the proposed transfer will be provided to Navigator customers via First Class United States mail on or about September 1, 2008, pursuant to Section 64.1120(e), Verification of Orders for Telecommunications Services, as amended, of Federal Communications Commission (FCC) rules<sup>1</sup>. A copy of the subscriber notice and letter of compliance filed with the FCC are attached hereto as **Exhibit F**.

8. The transaction is exclusively an acquisition of assets and does not involve a merger or consolidation, nor does the transaction require financing. The asset acquisition is intended exclusively to

enable Birch to provide telecommunications services to certain Navigator subscribers as new Birch subscribers.

As time is of the essence, Birch requests expeditious handling of this notification.

III. INAPPLICABILITY OF CARRIER VERIFICATION RULES

9. Pursuant to 4 CSR 240-33.150(4), upon approval of this Application by the Commission,

Birch may submit or execute a change in a Navigator subscriber's provider of telecommunications service on

behalf of such subscriber without obtaining authorization and verification in accordance with the procedures

prescribed in 4 CSR 240-33.150(2) and 4 CSR 240-33.150(3), provided that Birch has complied with the

requirements prescribed in 4 CSR 240-33.150(4), and provided further that such change is made in connection

with the transfer of assets under the Agreement.

IV. PUBLIC INTEREST, CONVENIENCE AND NECESSITY

10. Commission approval of Navigator's sale to Birch of the local and interexchange

telecommunications assets is in the public interest. The infusion of Navigator's telecommunications service

assets into Birch's existing operations will allow Birch to expand its operations and to achieve economies of

scale, thus enhancing Birch's ability to compete in the Missouri market for telecommunications services.

Missouri consumers will benefit from the expanded availability of innovative and economic

telecommunications products and service options.

V. NO TAX IMPACT

11. The Applicants do not anticipate that the proposed transfer of assets will have any impact on

the tax revenues of the Missouri political subdivisions in which any structure, facility or equipment of the

Applicants is located.

VI. NO PENDING ACTIONS OR FINAL UNSATISFIED JUDGMENTS

12. Currently there are no pending actions or final unsatisfied judgments or decisions against either of the Applicants from any state or federal agency or court which involve customer service or rates.

13. No annual report or assessment fees are overdue with respect to either of the Applicants in Missouri.

# VIII. REQUEST FOR WAIVER OF HEARING

14. Inasmuch as time is of the essence, Applicants respectfully request expeditious approval of the Application.

WHEREFORE, Applicants, Navigator and Birch, respectfully request the Commission to issue its Order Approving Navigator's sale of certain telecommunications service assets, specifically a portion of Navigator's customer base, to Birch, and granting such other relief as is reasonable in the circumstances.
