- 1. The Commission issued its Order Granting Certificate of Convenience and Necessity ("Order") on January 11, 2023 with an Effective Date of February 10, 2023.
- 2. The closing contemplated by the Order was completed on February 28, 2023.
- 3. MAWC filed a Notice of Closing on February 28, 2023.
- 4. MAWC hereby provides notice that pursuant to the Order, the following have been completed with copies provided to the Commission where applicable.
- (1) MAWC has provided the Customer Experience Department ("CXD") Staff an example of its actual communication with the Smithton area customers regarding its acquisition and operations of the water and sewer system assets, and how customers may reach MAWC;

- (5) MAWC will include the Stewartsville Systems customers in its established monthly reporting to the CXD Staff on customer service and billing issues, on an ongoing basis, after closing on the assets.
