## ORDER GRANTING REQUESTED EXTENSIONS

On December 1, 2010, Lake Region Water and Sewer Company ("Lake Region") filed a status report and requested an extension of time for the deadlines established for installing certain flow meters pursuant to the "Partial Non-Unanimous Stipulation Respecting Adjustments to Sewer Charges Applicable to the Racquet Club Condominium Property Owners Association, Inc." No party has opposed the request.

Based upon the engineering and technical requirements related to the flow meter installation, Lake Region specifically requests that the deadlines established in the Commission's order of October 6, 2010 be modified as follows:

- a. Lake Region should reinstall a total flow measurement assembly to be completed by January 31, 2011;
- b. Lake Region should test and verify the accuracy by March 31, 2011;
- c. After such verification, total flow data should be collected for six (6) months, April through September 2011; and
- d. In October 2011, the data from those six (6) months will be available to evaluate the options in measuring flow at other complex locations toward reducing and billing for excess flow. At that time Lake Region should file a report as to its current results and future plans.

For the reasons stated in Lake Region's motion, the Commission finds the request to be reasonable and will grant the unopposed motion.

**THE COMMISSION ORDERS THAT:**

1. The "Request for Second Extension" filed by Lake Region Water and Sewer Company on December 1, 2010, is granted.
2. The deadlines requested by Lake Region Water and Sewer Company in relation to installing the flow meters and determining the flow measurements as delineated in the Commission-approved Partial Nonunanimous Stipulation Respecting Adjustments to Sewer Charges Applicable to Intervenor Four Season Racquet And Country Club Condominium Owners Association, Inc. ("Stipulation") are adopted. The Signatories to the Stipulation shall comply with their respective obligations pursuant to these deadlines.
3. The Signatories shall continue to hold their planned periodic meetings, and file quarterly status reports.
4. This order shall become effective immediately upon issuance.
