I do hereby certify that the attached is an accurate and complete copy of the proposed rescission lawfully submitted by the Missouri Public Service Commission.



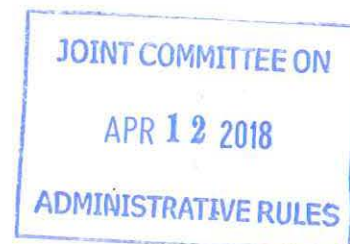
PURPOSE: This rule is being rescinded in its entirety because it is no longer necessary.

AUTHORITY: section 386.410, RSMo 2000. (Original authority: 386.410, RSMo 1939, amended 1947, 1977, 1996.) Original rule filed Dec. 30, 2003, effective Aug. 30, 2004.

PUBLIC COST: This proposed rescission will not cost state agencies or political subdivisions more than five hundred dollars (\$500) in the aggregate.

PRIVATE COST: This proposed rescission will not cost private entities more than five hundred dollars (\$500) in the aggregate.
