RESPONSE TO STAFF RECOMMENDATION

Comes now Laclede Gas Company ("Laclede" or "Company") and for its

Response to Staff Recommendation in the above captioned cases, states as follows:

- 1. On December 6, 2000, the Staff of the Missouri Public Service

 Commission ("Staff") filed its Recommendation and attached Memorandum in the abovecaptioned cases, in which it urged the Commission to approve the Unanimous Stipulation
 and Agreement ("S&A") filed in these cases on November 2, 2000.
- 2. Laclede notes that pursuant to numbered paragraph 9 of the S&A, the contents of Staff's Memorandum are its own and no signatory to the S&A shall be deemed to have acquiesced in or otherwise adopted the specific statements set forth therein. Subject to that understanding, however, Laclede fully supports and joins in Staff's recommendation that the S&A be approved.

3. In addition to recommending measures that should further enhance Laclede's ability to respond to emergency situations caused by third party damage, the S&A also proposes a variety of steps for preventing such damage in the first place -- a goal that has been emphasized by Laclede throughout this proceeding. To that end, Laclede commends both the Staff and the Office of the Public Counsel for their willingness to participate in a cooperative effort aimed at preventing such damage, including the kind of facility damage caused by horizontal boring activity that poses the greatest danger to public safety. Laclede believes that all of the measures outlined in the S&A, including: (a) increased efforts to educate utilities and excavators of their obligations under the Missouri One-Call Statute and the Commission's safety regulations relating to the installation of buried cable; (b) increased efforts to monitor and enforce compliance with these statutory and regulatory requirements; and (c) the continued pursuit of legislative initiatives aimed at preventing third party damage; will contribute to the achievement of this common goal. Laclede looks forward to working with the Parties in implementing this joint undertaking, and, in addition to fulfilling its obligations under the S&A, will provide whatever assistance it can to the Commission Staff's own efforts to implement and apply these measures in the future.

WHEREFORE, for the foregoing reasons, Laclede Gas Company respectfully

requests that the Commission approve the Unanimous Stipulation and Agreement filed in these cases on November 2, 2000.
