On September 29, 2016<sup>1</sup>, House Springs Sewer Company, Inc. ("HSSC") and Jefferson County Public Sewer District ("JCPSD")(collectively, "Applicants") filed a First Amendment to Joint Application, Request for Waiver for Good Cause, and Motion for Expedited Treatment. Those pleadings supplement Applicants' Joint Application filed on February 16, by which HSSC seeks Commission approval to sell substantially all its assets to JCPSD.

The Motion for Expedited Treatment asks the Commission to approve Applicants' application no later than October 25. The Commission will thus order its Staff, and permit the Office of Public Counsel, to respond to Applicants' September 29 pleadings.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Commission shall file a Recommendation or an alternative pleading no later than October 11, 2016.
2. If the Office of Public Counsel wishes to respond, it shall do so no later than October 11, 2016.
