UNANIMOUS STIPULATION OF FACTS

COME NOW Stoddard County Sewer Company, Inc. ("Stoddard County"), R.D. Sewer Co., L.L.C. ("R.D. Sewer"), and the Staff of the Missouri Public Service Commission ("Staff"), being all of the Applicants in this case, and the Office of the Public Counsel ("OPC"), and unanimously stipulate and agree as follows.

1. On March 24, 2008, Stoddard County, R.D. Sewer, and the Staff (collectively, "the Applicants") filed the Joint Application of Stoddard County Sewer Company, Inc., R.D. Sewer Co., L.L.C., and the Staff for an Order Authorizing Stoddard County Sewer Co. to Transfer Its Assets to R.D. Sewer Co. and Establishing New Rates for R.D. Sewer Co., Subject to Review ("the Joint Application").

2. The Applicants and OPC stipulate and agree that the following facts alleged from Paragraph 1 of the Joint Application are true and correct:

Stoddard County is a Missouri corporation, but is not in good standing. The corporation was administratively dissolved on September 14, 1999, for its failure to file an annual registration report within 30 days after it was due, and the dissolution has not been rescinded. Pursuant to the provisions of § 351.486,¹ Stoddard County's corporate existence

continues, but the dissolved corporation may not carry on any business except that necessary to wind up and liquidate its business and affairs pursuant to § 351.476, and to notify claimants pursuant to §§ 351.478 and 351.482.

3. Attached hereto and incorporated by reference herein as Attachment E is a true copy of the records currently maintained by the Missouri Secretary of State on her website that pertain to Stoddard County. Attachment E is an updated version of Attachment A, which was attached to the Joint Application. The Applicants and OPC unanimously stipulate and agree that if the words "Attachment E" are substituted for the words "Attachment A", the facts alleged in Paragraph 2 of the Joint Application are true and correct.

4. The Applicants and OPC stipulate and agree that the facts alleged in Paragraph 3 of the Joint Application are true and correct.

5. The Applicants and OPC stipulate and agree that the following facts alleged from Paragraph 4 of the Joint Application are true and correct:

Stoddard County is in the business of providing sewer services to the public.

6. The Applicants and OPC stipulate and agree that the facts alleged in Paragraph 7 of the Joint Application are true and correct.

7. The Applicants and OPC stipulate and agree that the following facts . alleged from Paragraph 8 of the Joint Application are true and correct:

Stoddard County has filed with the Commission all annual reports that became due after August 8, 2002. Applicant R.D. Sewer has paid all Commission assessments that became due after that date.

8. The Applicants and OPC stipulate and agree that the facts alleged in Paragraph 9 of the Joint Application are true and correct.

9. Attached hereto and incorporated by reference herein as Attachment F is a true copy of the records currently maintained by the Missouri Secretary of State on her website that pertain to R.D. Sewer. Attachment F is an updated version of Attachment B, which was attached to the Joint Application. The parties unanimously stipulate and agree that if the words "Attachment F" are substituted for the words "Attachment B", the facts alleged in Paragraph 10 of the Joint Application are true and correct.

10. The Applicants and OPC stipulate and agree that the following facts alleged from Paragraph 11 of the Joint Application are true and correct:

R.D. Sewer was organized to transact any and all lawful business for which a limited liability company may be organized.

11. The Applicants and OPC stipulate and agree that the facts alleged in Paragraph 12 of the Joint Application are true and correct.

12. The Applicants and OPC stipulate and agree that the facts alleged in Paragraphs 14 through 18 of the Joint Application are true and correct.

13. The Applicants and OPC stipulate and agree that the facts alleged in Paragraphs 22 through 25 of the Joint Application are true and correct.

14. The Applicants and OPC stipulate and agree that the following facts alleged from Paragraph 32 of the Joint Application are true and correct:

Applicant R.D. Sewer has not paid claims that Stoddard County incurred before August 8, 2002. R.D. Sewer has managed the business affairs of Stoddard County since then. For example, R.D. Sewer has paid Stoddard County's Commission assessments and submitted Stoddard County's Commission annual reports since that date, and, but for a few minor exceptions, has done so in a timely manner.

15. The Applicants and the OPC further stipulate and agree that the facts alleged in Paragraph 45 of the Joint Application are true and correct, but are incomplete.

The Applicants and the OPC stipulate that the following statement is true, correct, and

complete, to the best knowledge and belief of the Applicants and the OPC:

45.
