**SNGMO'S RESPONSE TO COMMISSION ORDER
AND REQUEST FOR CHANGE TO TARIFF EFFECTIVE DATE**

COMES NOW Summit Natural Gas of Missouri, Inc. ("SNGMO" or "Company"), and, for its Response to the Missouri Public Service Commission's ("Commission") November 7, 2022 *Order Directing Response ("Order")*, states as follows:

1. On November 3, 2022, SNGMO filed tariff sheets that reflect the Company's annual changes to the Company's Purchased Gas Adjustment ("PGA") clause in Tracking No. JG-2023-0087. These tariff sheets had an effective date of November 21, 2022. The Company's Commission-approved tariffs, P.S.C. MO No. 3, Original Sheet No. 15, allows the PGA factors to be approved if "it has been on file with the Commission for a period of ten (10) business days." The Company's tariffs as filed did not align with the time period set forth in the Company's tariffs, nor did it reflect the Company's intentions to put the new PGA rates into effect as soon as feasible. In order to correct this error and enable the Company to begin collecting under the new PGA rates as soon as possible, the Company submitted substitute tariff sheets on November 4, 2022, with an effective date of November 17, 2022. Since the Company is currently under earning on its cost of gas, this modification to the effective date will allow the Company to implement rates more reflective of the actual cost of gas as soon as possible. Once the Company discovered this error, it reached out to Staff Counsel to notify them of this change to the tariff effective date.

2. Since the Company substituted the change to the tariff effective dates as soon as it was aware of the error and provided expedient notice to Staff Counsel regarding this change, the

Company respectfully requests that the Commission allow the substitution of its tariffs to reflect the date of November 17, 2022.


