The accompanying tariff sheets issued by Summit Natural Gas of Missouri, Inc. (“SNGMO” or the “Company”) are being transmitted for filing:

These tariff sheets are being issued November 4, 2021, to become effective on and after November 15, 2021.

These revised sheets include changes to Company’s Purchased Gas Adjustment (PGA) Clause as approved by the Commission. These revisions reflect adjustments to the Regular Purchased Gas Adjustment (RPGA) and Actual Cost Adjustment (ACA) factors.

The changes in the PGA factors applicable to the Company’s Gallatin Division will increase the firm sales customers’ Total PGA from \$0.3779/Ccf to \$0.6101/Ccf. The proposed increase will cause an average winter month residential gas bill to increase by approximately \$29.60. This represents a 20.79% increase for the average month in the heating season.

The changes in the PGA factors applicable to the Company’s Warsaw and Lake of the Ozarks Divisions will increase the sales customers’ Total PGA from \$0.3778/Ccf to \$0.7395/Ccf. The proposed increase will cause an average winter month residential gas bill to increase by approximately \$22.08. This represents a 21.72% increase for the average month in the heating season.

The changes in the PGA factors applicable to the Company’s Rogersville and Branson Divisions will increase the firm sales customers’ Total PGA from \$0.4216/Ccf to \$0.7327/Ccf. The proposed increase



will cause an average winter month residential gas bill to increase by approximately \$30.02. This represents a 23.15% increase for the average month in the heating season.

We are enclosing workpapers supporting this filing with the copy of this filing being provided to the Staff. The workpapers have been designated "Highly Confidential" since they contain market specific information directly relating to the natural gas markets where Summit Natural Gas of Missouri, Inc. must compete for its gas supplies. The Company requests that these workpapers be handled in a manner consistent with this designation.
