## ORDER PROVIDING NOTICE, ESTABLISHING INTERVENTION DEADLINE, AND DIRECTING RESPONSE

On November 17, 2008, KMB Utility Corporation and Triple C Development LLC filed a joint application asking the Commission to approve the transfer of the assets of Cape Rock Village Sewer System from KMB Utility to Triple C. The sewer system that the applicants intend to transfer serves the Cape Rock Village and Tanglewood Subdivision areas of Cape Girardeau County, Missouri.

Before considering the joint application, the Commission will provide notice to the public, and will establish an intervention deadline. KMB Utility and Triple C have asked the Commission to act on their application by December 15, 2008. Therefore, the Commission will establish a date for its Staff and other interested parties to offer recommendations regarding the joint application.
