**ORDER GRANTING MOTION FOR ADDITIONAL EXTENSION OF TIME**  
**TO FILE DIRECT TESTIMONY**

On August 24, 1998, the Commission issued an Order Adopting Procedural Schedule which required that Timber Creek Sewer Company (TCSC) file its direct testimony by September 8, 1998 at 3:00 p.m. On September 17, 1998, the Commission entered an Order which extended the date for filing of direct testimony by TCSC to September 18, 1998. On September 17, TCSC filed a Motion for Additional Extension of Time to File Direct Testimony. By that Motion, TCSC requested that it be allowed until October 9 to file its direct testimony. No party has filed an objection to the requested extension of time.

**IT IS THEREFORE ORDERED:**

1. That Timber Creek Sewer Company's Motion for Additional Extension of Time to File Direct Testimony is granted.
2. That Timber Creek Sewer Company shall file its Direct Testimony by October 9, 1998 at 3:00 p.m.
3. That in all other respects, the procedural schedule previously adopted in this case shall be unchanged.
4. That this order shall become effective on October 13, 1998.
