**STAFF RESPONSE TO COMMISSION ORDER
REGARDING PROPOSED DATE FOR PREHEARING CONFERENCE**

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, in response to the Missouri Public Service Commission’s (“Commission”) November 6, 2015 Order Directing Filing regarding a prehearing conference for the drafting of a procedural schedule, including evidentiary hearings, concerning the Application of South Central MCN LLC filed August 19, 2015. In support thereof, the Staff states as follows:

1.
