ORDER APPROVING INTEREXCHANGE AND NONSWITCHED LOCAL EXCHANGE CERTIFICATE OF SERVICE AUTHORITY AND ORDER APPROVING TARIFF

Southwest Fiber Communications, Inc. (Southwest Fiber) applied to the Public Service Commission on June 8, 1998, for a certificate of service authority to provide intrastate interexchange and nonswitched local exchange telecommunications services in Missouri under Section 392.410-.450, RSMo 1994 and RSMo Supp. 1997. Southwest Fiber asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. Southwest Fiber is a Missouri corporation, with its principal office located at 1023 South Springfield, Bolivar, Missouri 65613.

The Commission issued a Notice of Applications and Opportunity to Intervene on June 16, directing parties wishing to intervene to file their requests by July 1. The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present evidence. State ex rel.

Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494, 496 (Mo. App. 1989). Since no one has asked permission

to intervene or requested a hearing, the Commission may grant the relief requested based on the verified application.

Southwest Fiber filed a proposed tariff in conjunction with its application with an effective date of August 1. Southwest Fiber's tariff describes the rates, rules, and regulations it intends to use, identifies Southwest Fiber as a competitive company, and lists the waivers requested. Southwest Fiber intends to provide interexchange and nonswitched local exchange telecommunications services including private line services.

In its Memorandum filed on July 20, the Staff of the Commission stated that Southwest Fiber's proposed services are similar to existing IXC offerings. Staff recommended that the Commission grant Southwest Fiber a certificate of interexchange service authority and a certificate of service authority for local exchange telecommunication service on condition that this authority be restricted to providing dedicated, nonswitched local exchange private line services. Staff recommended that the Commission grant Southwest Fiber competitive status and waiver of the statutes and rules listed in the Notice. Staff recommended that the Commission approve the proposed tariff to become effective on August 1.

The Commission finds that competition in the intrastate interexchange and nonswitched local exchange telecommunications markets is in the public interest and Southwest Fiber should be granted certificates of service authority. The Commission finds that the services Southwest Fiber proposes to offer are competitive and Southwest Fiber should be classified as a competitive company. The Commission finds that waiving the statutes and Commission rules set out in the

ordered paragraph below is reasonable and not detrimental to the public interest.

The Commission finds that Southwest Fiber's proposed tariff details the service, equipment, and pricing it proposes to offer, and is similar to tariffs approved for other Missouri certificated interexchange and local exchange carriers. The Commission finds that the proposed tariff filed on June 8 should be approved to become effective on August 1.

IT IS THEREFORE ORDERED:

- 1. That Southwest Fiber Communications, Inc. is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, subject to all applicable statutes and Commission rules except as specified in this order.
- 2. That Southwest Fiber Communications, Inc. is granted a certificate of service authority to provide local exchange telecommunications services in the state of Missouri limited to providing dedicated, nonswitched local exchange private line services, subject to all applicable statutes and Commission rules except as specified in this order.
- 3. That Southwest Fiber Communications, Inc. is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived:
