**ORDER APPROVING TARIFF SHEETS FILED IN COMPLIANCE
WITH STIPULATION AND AGREEMENT**

On November 4, 1997, the Commission issued a Report and Order which approved a Stipulation and Agreement filed in this case. On November 14 Fidelity Natural Gas, Inc. (Fidelity or Company) filed tariff sheets as directed by the Report and Order.

On November 21 the Staff of the Missouri Public Service Commission (Staff) filed a memorandum to the official case file. Staff notes that tariff Sheet No. 23 filed with the Stipulation and Agreement omits a sentence but that the omission has been remedied in Fidelity's compliance filing.

Fidelity stated, in a letter attached to the compliance filing, that it proposes use of its current PGA factors as its scheduled winter filing, and that further PGA filings will be made pursuant to the terms of these tariff sheets.

Staff states that it has reviewed the filed tariff sheets and has determined that they substantially reflect the same form as those attached to the Stipulation and Agreement. Therefore, Staff recommends that the following tariff sheets be approved for service rendered on and after December 1, 1997.

The Commission has reviewed the proposed tariff sheets and the Staff's recommendation. The Commission determines that the proposed tariff sheets comply with the Commission's Report and Order.

IT IS THEREFORE ORDERED:

1. That the following tariff sheets be approved for service rendered on and after December 1, 1997.
