ORDER APPROVING TARIFF

On June 20, 1997, the Commission issued its Report and Order in this case. In that order, the Commission rejected the proposed tariff, No. 9600705, as submitted by GTE Midwest Incorporated (GTE) on May 13, 1996. The Commission directed GTE to file a tariff substantially similar to the proposed tariff but with the exception that intraLATA dialing parity shall not be implemented in Community Optional Service (COS) target exchanges and their associated Extended Area Service (EAS) exchanges pending a Commission decision in Case No. TW-97-333.

On July 3, 1997, GTE filed its proposed tariff in compliance with the Commission's Report and Order. This tariff was assigned Tariff File No. 9800015 and was filed in this case. The proposed effective date for these tariffs is August 3, 1997. On July 15, the Telecommunications Department Staff (Staff) filed its memorandum in this case regarding the tariff as filed by GTE. Staff has stated that in addition to the changes necessary to implement intraLATA presubscription consistent with the Commission's Report and Order, GTE has made minor additional modifications in its tariff that do not substantially change the tariff nor change rates.

Staff stated that it has analyzed the tariff revisions and believes they are consistent with the Commission's Report and Order. Staff has recommended that the tariff revisions be approved as filed herein. Staff has noted that the cost of intraLATA presubscription is calculated by GTE to be \$1,417,044. This cost is to be recovered over three years

from the first exchange implementation date as a equal access cost recovery charge at the rate of \$0.0007185 per intrastate interLATA and intrastate intraLATA originating minute. At the end of the three year period, GTE must file tariff revisions to remove the equal access recovery charge pursuant to the Commission's order.

In addition to the proposed tariff, GTE submitted its proposed customer notice to the administrative law judge to whom this case is assigned on July 3, 1997. A copy of that notice, as approved by the Commission, is attached to this order and approved for dissemination by GTE.

The Commission has reviewed the proposed tariff sheets as filed by GTE, the Staff memorandum and the entirety of the file and finds that the tariff sheets, as filed, incorporate the changes directed by the Commission's Report and Order in this case. The Commission finds that the tariff sheets are in compliance with the Commission's order and should be approved for the introduction of intraLATA equal access in GTE's exchanges.

IT IS THEREFORE ORDERED:

1. That the tariff sheets filed by GTE Midwest Incorporated in this case and also filed under Tariff File No. 9800015 shall be approved for service on and after August 3, 1997.

Missouri Customers Will Now Have the Option to Choose IntraLATA Providers

Missouri residential and business customers will soon have the option of selecting a long distance company to handle their intraLATA 1+ and 0+ calls, currently carried by GTE. These are long distance calls to nearby communities for which long distance charges apply. Missouri is divided into major long distance calling areas called LATAs. IntraLATA calls are long distance calls to communities that are outside your local calling area, but "within" your LATA, and often within the state. (See map).

Currently, GTE carries all your 1+ and 0+ calls within your LATA. Beginning August 8, 1997 you will have the option of selecting another long distance company for your intraLATA 1+ and 0+ calling. This means that any long distance company can be used to place an intraLATA call without dialing additional digits. Long distance service providers may have already contacted you to market these services.

You may select an intraLATA long distance company at no charge by contacting the long distance service provider of your choice, or by calling GTE at 1-800-483-3400. If you do not choose another intraLATA service provider, GTE will continue to provide your intraLATA long distance service.

You can change your intraLATA provider one time at no charge. Each change after that will cost \$3.92.

(As a footnote to the map?) Please note that if you presently subscribe to a Community Optional Service (COS) flat-rate dialing plan through your local telephone company, your selection of a different intraLATA carrier may affect that service.
