ORDER RECOGNIZING NAME CHANGE AND APPROVING TARIFF AS AMENDED BY ADOPTION NOTICE

On September 19, 1997, Dial & Save of Missouri, Inc. d/b/a Dial & Save (Dial & Save) submitted an adoption notice to the Public Service Commission (Commission) which reflected that as of September 22, Dial & Save would be operating under the new corporate name Telco Holdings, Inc. (THI) d/b/a Dial & Save. This adoption notice was submitted pursuant to 4 CSR 240-30.010(22), which provides that an adoption notice may be made effective as of the date it is filed with the Commission. As a result, the Company's amended tariff became effective on September 22, 1997.

In a letter accompanying the filing, counsel for Dial & Save stated the Company's new name resulted from an internal reorganization of Dial & Save's parent corporation, Telco Communications Group, Inc. The Company stated that Dial & Save, along with its sister Dial & Save corporations nationwide, are being reorganized into a new Delaware corporation, Telco Holdings, Inc. d/b/a Dial & Save. Included with the filing were copies of THI's Certificate of Authority to transact business in this state and THI's Registration of Fictitious Name from the Missouri Secretary of State.

, K 0 Dial & Save was certificated to provide intrastate interexchange telecommunications services on June 27, 1995, in Case No. TA-95-298. The Company was also granted a certificate of service authority to provide local exchange telecommunications services and basic local telecommunications services on May 27, 1997, in Case No. TA-97-7. In both cases, Dial & Save was classified as a competitive telecommunications company and granted waiver of Section 392.340 of the Revised Statutes of Missouri¹.

On September 25, the Staff of the Missouri Public Service Commission (Staff) filed a memorandum stating that Staff had no objection to the Company's filing and recommending that the Commission issue an order recognizing the change of corporate name and approving the adoption notice as part of Dial & Save's tariff. Staff states that it is unaware of any other filing which affects or which would be affected by this proposal.

Having reviewed Company's filing and Staff's recommendation, the Commission finds that Dial & Save's change of corporate name should be recognized and the adoption notice should be approved and incorporated into the Company's tariff.

IT IS THEREFORE ORDERED:

- 1. That the Company's change of corporate name from "Dial & Save of Missouri, Inc. d/b/a Dial & Save " to "Telco Holdings, Inc. d/b/a Dial & Save" is recognized.
- 2. That the certificates of service authority previously issued to Dial & Save of Missouri, Inc. d/b/a Dial & Save in Case No. TA-95-298 on June 27, 1995, and in Case No. TA-97-7 on May 27, 1997, are amended to

reflect the change in corporate name from "Dial & Save of Missouri, Inc. d/b/a Dial & Save", to "Telco Holdings, Inc. d/b/a Dial & Save".

3. That the tariff sheet filed by Telco Holdings, Inc. d/b/a Dial & Save on September 19, 1997, is approved. The tariff sheet approved is:

- 4. That this order shall become effective on October 21, 1997.
- 5. That this case shall be closed on October 22, 1997.
