ORDER APPROVING EXTENSION OF SCHEDULE

On December 15, 1994, UtiliCorp United, d/b/a Missouri Public Service (UtiliCorp) filed an application with the Commission for an extension of time in which to file its Electric Utility Resource Plan pursuant to 4 CSR 240-22.080(3). As its reason, UtiliCorp stated in its application, generally, that it needs additional time in which to develop its computer models and databases.

On January 9, 1995, the Staff of the Commission filed its response in which it agreed that the proposed extension should be granted and, with the consent of UtiliCorp and the Office of Public Counsel (OPC), recommended approval of an agreed-upon schedule for filings, responses, and meetings in which to discuss UtiliCorp's filing.

In accordance with 4 CSR 240-22.080(12), the Commission may extend or reduce any scheduled filing under this rule for good cause shown. In reviewing the application of UtiliCorp, the Commission notes that the design and modifications to custom computer models and databases to comply with the requirements of the integrated resource plan appear

to be complex and extensive. Both the OPC and the Staff of the Commission have consented to the proposed extension. The Commission, therefore, finds that good cause exists to grant the proposed extension.

In addition, the response of the Staff contains specific dates for the filing of various portions of UtiliCorp's Integrated Resource Plan and a proposed schedule of meetings. As the remainder of this proposed schedule is agreed to and requested by all of the parties, the Commission will also authorize this requested schedule.

IT IS THEREFORE ORDERED:

- 1. That the application of UtiliCorp for an extension of time in which to file its Electric Utility Resource Plan is hereby granted and the following schedule, agreed to by the parties, is ordered; that UtiliCorp will make its filings in compliance with 4 CSR 240-22.030, 040, and 050 no later than 3:00 p.m., March 9, 1995; that UtiliCorp will make its filings in compliance with 4 CSR 240-22.060, 070, and 080 no later than 3:00 p.m., April 7, 1995.
- 2. That, per agreement between the parties, the following schedule of meetings regarding UtiliCorp's Integrated Resource Plan are set as follows:
