ORDER APPROVING TARIFFS AND CLOSING CASE

On November 9, 1989, Bowling Green Gas Company (Company) of Bowling Green, Missouri, submitted to this Commission for approval, a tariff which reflected a change in rates as a result of the recalculation of the Company's Actual Cost Adjustment (ACA) factor. The tariff was approved to become effective November 21, 1989, interim subject to refund in order to allow Staff additional time to complete its review of the ACA filing.

On March 30, 1990, Staff submitted a memorandum to Case No. GR-90-99 which indicated the audit of Company's 1988-1989 ACA filing was completed. Several adjustments were recommended in that memorandum including a proposed change to the transportation tariffs that would provide for the recovery of a portion of the Company's lost and unaccounted for gas and Take-or-Pay costs from the Company's transportation customers.

On April 9, 1990, Company submitted for Commission approval a tariff which incorporated a revised ACA factor designed to refund an additional \$5,181 as a result of the audit. The tariff reflected an effective date of April 23, 1990.

On April 23, 1990, Company submitted for Commission approval, tariffs which reflected proposed changes to the transportation tariffs as well as changes to the PGA Clause designed to effect a more timely passthrough of spot market savings and to reduce the frequency of PGA filings.

Staff recommended the proposed tariffs be approved. Additionally, Staff expressed its opinion that with the approval of the proposed tariffs, Case No. GR-90-99 was no longer necessary, and consequently it was recommended that it be closed.

After reviewing Staff's recommendations, the Commission is of the opinion that the proposed tariff sheets should be allowed to go into effect on the requested effective date, May 23, 1990. The Commission is also of the opinion that Case No. GR-90-99 should be closed.

It is, therefore,

ORDERED: 1. That the following tariff sheets submitted April 23, 1990, by Bowling Green Gas Company, of Bowling Green, Missouri, for the purpose of reflecting changes in the PGA Clause, the transportation tariffs and the PGA factor be, and the same are, hereby authorized to become effective on May 23, 1990.
