ORDER APPROVING TARIFF SHEETS

On September 26, 1994, Sprint Communications Company, L.P. (Sprint) filed tariff sheets designed to introduce "Time Bank" and "Business Sense" Services, and to adjust term commitment plans for subscribers to "The Most For Business" Service. Sprint requested expedited treatment of the tariff sheets to allow for an effective date of October 15, 1994.

"Time Bank" is a message telecommunications service (MTS) which credits one free minute of domestic usage for every five minutes of paid usage. Free minutes are earned when total paid usage per invoice exceeds \$30 and additional bonus minutes would be given for usage in excess of 180 paid minutes. "Business Sense" is a service which proposes to offer small business customers the option of choosing a flat rate calling plan for all domestic and international calling. The service is neither distance sensitive nor time-of-day or day-of-week sensitive. Rates are determined by the level of usage and the customer's choice of one, two, or three year term commitment.

Sprint is also proposing to eliminate the six month and eighteen month subscription periods for "The Most For Business" subscribers. Subscribers to "The Most For Business" receive volume discounts based on usage and monthly term commitments. In addition to

eliminating the six and eighteen month periods, Sprint is proposing to offer 24 and 48 month commitment periods. Subscribers to the commitment periods being eliminated would be allowed to continue subscribing until their contracts expire.

On October 6, 1994, the Staff of the Commission (Staff) filed a memorandum recommending that the Commission approve Sprint's proposed tariff sheets. Staff stated that it has no objections to the proposed tariff sheets or to their approval on an expedited basis.

Upon review of the proposed tariff sheets and Staff's recommendation, the Commission finds that Sprint's proposal is reasonable. Thus, the Commission determines that the tariff sheets filed by Sprint on September 26, 1994 should be approved for service on and after October 15, 1994.

IT IS THEREFORE ORDERED:

1. That the following tariff sheets filed by Sprint Communications company, L.P. are hereby approved for service on and after October 15, 1994:
