Corporation's tariff revision designed to introduce a promotion for customers of dedicated leased line service.

ORDER APPROVING TARIFF

On August 4, 1995, MCI Telecommunications Corporation (MCI) submitted a proposed revision to its Intercity Telecommunications Services Tariff, M.P.S.C. Tariff No. 1, to add an Original Page No. 38.7, which would introduce a promotion for Dedicated Leased Line Service customers. The proposed promotion would waive the Inter-Office Channel (IOC) charge for the month of March 1996 for customers who subscribed to Voice Grade Private Line, Digital Private Line, and Terrestrial Digital 1.5 services. MCI requests expedited approval of this tariff filing effective September 1, 1995, to coincide with the restructure of Dedicated Leased Line Service in File No. 9600074.

The Commission's Staff filed its recommendation on August 21, 1995, stating therein that the Staff has no objections to the proposed tariff filing or MCI's request for expedited Commission consideration of this proposal, and therefore recommends approval of the proposed tariff filing at the Commission's earliest convenience with an effective date concurrent with Commission approval. Staff notes that existing customers of the services involved in the proposed promotion will automatically receive the waiver on their bill without requesting the promotion. Staff also indicates that customers who order the aforementioned services prior

to September 30, 1995, and have them installed prior to November 30, 1995, will also be eligible for the promotion, although those customers must remain in service through February 29, 1996 in order to receive the waiver. In addition, Staff adds that it is unaware of any other filing which affects or which would be affected by this proposal.

The Commission finds that the Staff's recommendation is appropriate, and that the tariff filing and the rates subsumed under the tariff filing are just and reasonable. The Commission is also of the opinion that MCI's tariff submission should be granted expedited treatment to allow the tariff to become effective immediately upon Commission approval, so that the tariff submission may coincide with the restructure of Dedicated Leased Line Service in File No. 9600074. Thus, the Commission approves the tariff submission of MCI.

IT IS THEREFORE ORDERED:

1. That the following tariff sheet submitted by MCI Telecommunications Corporation on August 4, 1995, be hereby approved to become effective August 26, 1995:

2. That this Order shall become effective on August 26, 1995.
