QUARTERLY STATUS REPORT

COMES NOW Lake Region Water and Sewer Company ("Lake Region" or "Company") and for this quarterly status report submits the following to the Commission:

1. On April 14, 2011, the Company started taking daily readings each workday for the Parshall Flume and the associated water meters. The data was forwarded to Staff Engineer Martin Hummel periodically. At the suggestion of Mr. Hummel, the Company began to take readings on weekends and holidays beginning June 15, 2011. On June 20, 2011, the Racquet Club POA began taking daily readings on its water meter which controls the landscaping irrigation system.

2. Staff Engineers Martin Hummel and Jim Merciel visited the site with Company personnel and John Walker of the Racquet Club POA on June 30, 2011 to test the accuracy of the installed flow meter.

3. Mr. Hummel met with John Walker of the Racquet Club POA, Ron Schlicht of the Country Club Hotel and John Summers of the Company on July 7, 2011 to discuss the status of the flow meter and the data collected thus far. After analyzing the data supplied by the Company and Racquet Club POA, and taking into account the test done on June 30, 2011, Mr. Hummel believes the flow meter is accurate for billing purposes.

4. The parties agreed to continue collecting data and agreed that Mr. Hummel should analyze the July data to determine: 1) whether adjustment of flow measurement is needed; and 2) the magnitude of the infiltration and inflow (I & I) problem. During this process of establishing measurement of flow to the wastewater treatment plant, progress has been made in reducing the I & I.
