## **ORDER AND NOTICE**

On September 15, 2017, Ameren Transmission Company of Illinois ("ATXI") asked the Commission to grant ATXI a certificate of convenience and necessity to build the above-referenced project.<sup>1</sup>

The Commission finds that notice of the application should be given to the general public and interested parties and a date for intervention of proper parties should be set. The Commission's Data Center shall mail a copy of this notice to the County Commissions of Marion, Lewis, Knox, Adair and Schuyler. In addition, the Commission's public information officer shall make notice of this order available to the media serving those counties and to the members of the General Assembly representing those counties.

The requirement of a hearing has been fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party or governmental entity is granted intervention, and neither the Commission's Staff nor the Office of the Public

Counsel requests a hearing, the Commission may determine that a hearing is not necessary for a determination on the application.<sup>2</sup>

2. The Missouri Public Service Commission's public information officer is ordered to serve notice as described in the body of this order.

3. Any proper person wishing to intervene in this matter shall file an application
