On March 28, 2007, West 16th Street Sewer Company ("16th Street") filed a revised tariff sheet, effective April 27, to implement a small sewer company rate increase

pursuant to Commission Rule 4 CSR 240-3.330. In addition to the tariff, which has been

assigned Tariff Tracking No. YS-2007-0685, 16th Street submitted a cover letter stating

that 16th Street, the Staff of the Missouri Public Service Commission, and the Office of the

Public Counsel had executed a Unanimous Agreement Regarding Disposition of Small

Sewer Company Rate Increase Request ("Disposition Agreement"). The letter further

stated that Staff would file the Disposition Agreement.

By order dated March 29, the Commission directed Staff to file the Disposition

Agreement, along with a recommendation regarding the Agreement and associated tariff,

by no later than April 9. The Commission also ordered 16th Street to file, by April 9, its

written consent to the extension of the 150-day filing requirement established by

Commission Rule 4 CSR 240-3.330(1)(F).

On March 30, Staff filed a copy of the Disposition Agreement, along with attachments consisting of various other documents related to the Agreement. Staff further pointed out that on March 19, Staff and 16th Street had already consented in writing to an extension of the 150-day tariff filing period that normally applies to small sewer company rate increase requests, and that this document had been filed in Tracking File No. QS-2007-0004. Finally, Staff indicated that it would be able to file its recommendation in this matter by close of business on April 13.

## IT IS ORDERED THAT:

- 1. The Commission acknowledges that the parties have timely filed both the Disposition Agreement and their written consent to the extension of the 150-day filing requirement contained in Commission Rule 4 CSR 240-3.330(1)(F).
- 2. The date by which the Staff of the Missouri Public Service Commission shall file its recommendation regarding the Disposition Agreement and the associated tariff is modified from April 9, 2007 to April 13, 2007.
  - 3. This order shall become effective on April 2, 2007.
