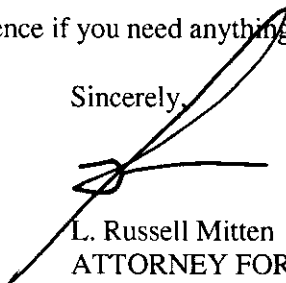
Dear Secretary Dale:

The period after which payment will then be considered delinquent is 21 days after rendition of the bill. A charge of \$5.00 or three percent (3%) per month times the unpaid balance, whichever is more, will be added to delinquent amounts.

A returned check charge of \$25 per check will be paid by customers on all checks returned unpaid from the bank.
