**NOTICE OF CORRECTION TO UNANIMOUS AGREEMENT**  
**ATTACHMENTS B AND C**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through the undersigned counsel, and submits to the Missouri Public Service Commission (Commission) its Notice of Correction to Unanimous Agreement Attachments B and C, and states the following:

1. On July 29, 2009, Staff filed the *Unanimous Agreement Regarding Disposition of Small Sewer Company Revenue Increase Request* (Unanimous Agreement).

2. On July 30, 2009, it was discovered that ten duplex customers were inadvertently included in the multi-family customer class instead of the single family customer class in Staff's revenue annualization. This discovery changed the original number of 101 single family customers and 67 multi family customers to the corrected 111 single family customers and 57 multi family customers. These numbers were used to calculate the rates in the originally filed Rate Design Worksheet, labeled Attachment B, and the originally filed Billing Comparison Worksheet, labeled Attachment C.

3. Therefore, Staff files this Corrected Attachment B and Corrected Attachment C, to be substituted for the incorrect Attachment B and C filed on July 29, 2009.

4. Staff also notes that this rate design correction changes the rates listed as "single family \$26.68, multi family \$21.35" in the Example Tariff Sheets filed as Attachment A. The

actual tariff sheets the Company will file shall list the corrected rates of “single family \$26.64, multi family \$21.31.”

**WHEREFORE**, Staff respectfully submits for the Commission’s information and consideration its Notice of Correction to Unanimous Agreement Attachments B and C filed July 29, 2009.
