MOTION TO SUSPEND EFFECTIVE DATE OF TARIFF SHEET

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and for its Motion to Suspend Effective Date of Tariff Sheet ("Motion") states the following to the Missouri Public Service Commission ("Commission").

1. By a letter dated March 30, 2006 (unless noted otherwise, all dates hereafter refer to the year 2006), which was received in the Commission's Data Center on April 3, Taneycomo Highlands, Inc. ("Company") filed a proposed revised tariff sheet with the Commission for the purpose of implementing the provisions of a *Unanimous Agreement Regarding Disposition of Small Sewer Company Rate Increase Request* ("Disposition Agreement"), and the instant case was established. The subject tariff sheet bore an issue date of March 30 and a proposed effective date of April 30. Upon receipt of the Company's tariff filing, personnel in the Commission's Data Center entered the filing into the Commission's electronic filing and information system and the filing was assigned Tariff File No. YS-2006-0749.

2. In preparing its recommendation for approval of the Company's pending revised tariff sheet, which it intended to file on April 19, the Staff reviewed the status of the Company's annual report submissions and assessment payments. As a result of that review, the Staff discovered that the Company's CY2005 annual report has not yet been submitted (or at least has not yet been entered into the Commission's electronic filing and information system). However, during a telephone conversation with the Company's Vice President, Staff member Jim Russo was advised that the Company's annual report had been sent to the Commission in March.

3. In order to allow time for the correct status of the Company's annual report submission to be determined, or for the Company to submit another copy of its CY2005 annual report, if necessary, the Staff believes that the effective date of the Company's pending proposed revised tariff sheet should be suspended for thirty days past the current proposed effective date.

WHEREFORE, the Staff respectfully requests that the Commission issue an order suspending the effective date of the proposed revised tariff sheet pending in Tariff File No. YS-2006-0749 until May 30.
