## ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE AND DIRECTING FILING

On August 19, 2011, Missouri American Water Company ("MAWC") submitted tariff sheets designed to implement a general rate increase for water and sewer service provided in its Roark Division. The tariff sheets carry an effective date of September 19, 2011. MAWC also outlines its position for consolidating these matters with its current rate case files, SR-2011-0338 and WR-2011-0337.

The Commission's Data Center will be directed to serve a copy of this order upon the county commissions of the counties in MAWC's service area and upon parties to the file numbers identified in the numbered paragraphs below. In addition, the Commission's Public Information Office will be directed to make notice of this order available to the media serving MAWC's service area and to the members of the General Assembly representing that area. The Commission will also set a deadline for intervention requests and direct a response to MAWC's proposal that these matters be consolidated with File Numbers SR-2011-0338 and WR-2011-0337.

### THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall serve a copy of this order upon the county commission of each county within Missouri American Water Company's ("MAWC") service area.

2. The Commission's Data Center shall serve a copy of this order upon the parties in File Numbers SR-2005-0153, WR-2005-0154, WO-2011-0213, WR-2011-0337 and SR-2011-0338.

3. The Commission's Public Information Office shall make notice of this order available to the members of the General Assembly representing MAWC's service area and to the news media serving MAWC's service area.

4. Any application to intervene shall be filed no later than September 2, 2011 with:
