JOINT PROCEDURAL SCHEDULE AND REQUEST FOR WAIVER

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and, on behalf of itself, Lincoln County Sewer & Water, LLC (Lincoln County), and the Office of Public Counsel (Public Counsel), states as follows:

- On December 4, 2012, Lincoln County filed requests before the Missouri Public Service Commission (Commission) for increases in water and sewer operating system revenues.
- 2. On July 2, 2013, having been unable to reach agreement with Lincoln County on the increase request, Staff filed a request for a hearing in this matter.
- 3. On July 31, 2013, the Commission ordered the parties to agree upon and file a proposed procedural schedule. In compliance with that Order, the parties hereby propose and respectfully request the Commission adopt the following:

Data Request response time shall be 10

calendar days to respond/ 5 to object August 15, 2013

Local Public Hearing August 20, 2013

Direct September 4, 2013

Rebuttal September 25, 2013

Data Request response time changes to

5 business days to respond/2 to object September 26, 2013

Surrebuttal October 16, 2013
Close of Discovery October 18, 2013
List of Issues/Witnesses and October 25, 2013

Order of Cross/Openings

Statements of Positions October 30, 2013

Hearing November 5-6, 2013

Briefs November 22, 2013

- 4. Pursuant to 4 CSR 240-3.050, the Commission's decision and order regarding this case should be issued and effective no later than eleven months after the case was opened. In this case, the eleven-month deadline is November 4, 2013. The parties have agreed to request this provision of 4 CSR 240-3.050 be waived in order to accommodate the agreed-upon schedule as laid out above. The parties have made efforts to fit a workable procedural schedule into the remaining time before November 4. However, due to the number of issues upon which all parties must write testimony and scheduling conflicts of witnesses and counsel, the above hearing dates were the earliest dates the parties could agree upon.
- 5. As reflected in the above procedural schedule, the parties make the following agreements regarding discovery:
 - a. Until rebuttal testimony is filed on September 25, 2013, the response time for all data request shall be ten (10) calendar days, with five (5) calendar days to object or notify the requesting party that more than ten (10) days will be necessary to provide the requested information.
 - b. After rebuttal testimony is filed on September 25, 2013, the response time for all data request shall be five (5) business days, with two (2) business

days to object or notify the requesting party that more than five (5) days will be necessary to provide the requested information

All data requests or other discovery requests shall be issued no later than
 October 18, 2013.

WHEREFORE, Lincoln County, Public Counsel, and Staff submit this jointly proposed procedural schedule and list of agreements and request the Commission adopt the proposed procedural schedule, approve the agreements, and grant what further relief it deems just and appropriate.
