SUPPLEMENT TO REVISED RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its Supplement to Revised Recommendation ("Supplement") states the following to the Missouri Public Service Commission ("Commission").

1. On June 16, 2006, the Staff filed Staff's Revised Recommendation Regarding Disposition of Small Company Rate Increase Request in this case ("Revised Recommendation"), and included therewith its Revised Official Case File Memorandum ("Revised Memorandum").

2. In its Revised Memorandum, the Staff discussed the issue of certain Department of Natural Resources ("DNR") discharge monitoring records that Taneycomo Highlands, Inc. ("Company") had not provided to the DNR as it was required to do. Additionally, the Staff noted that a representative of the Company had informed a Staff member in the Water & Sewer Department that the Company provided the subject monitoring reports to the DNR's Southwest Regional Office in Springfield on May 24, 2006. The Staff further noted that it had attempted to confirm that the DNR's Southwest Regional Office had received the subject reports and determine whether the DNR may take enforcement actions with regard to this matter, but that it had not yet been able to discuss this matter fully with the necessary DNR staff member. Lastly, the Staff stated that if it was able to discuss this matter fully with the necessary DNR staff member within the next few days, it would file a pleading including the information it obtained from the DNR about this matter.

3. On June 21, 2006, Jerry Scheible of the Water & Sewer Department spoke with Ms. Tina White of the DNR's Southwest Regional Office, and also received a voice-mail message from Mr. Kevin Hess of that office, regarding the DNR's receipt of the subject monitoring reports. Both Ms. White and Mr. Hess confirmed that the DNR has received the subject reports from the Company, as had been reported to the Staff, that the reports have been entered into the DNR's monitoring records data base, and that they did not anticipate that the DNR would take any formal enforcement actions regarding the reporting issues.

WHEREFORE, the Staff respectfully submits this Supplement for the Commission's information and respectfully reiterates its recommendation that the Commission issue an order consistent with the recommendations set out on page 5 of the Staff's Revised Memorandum.


