**STAFF’S NOTICE OF MANAGER RESIGNATION AND  
REQUEST FOR EXTENSION TO FILE QUARTERLY STATUS REPORT**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its *Notice of Manager Resignation and Request for Extension to File Quarterly Status Report* states the following:

1. Pursuant to the Commission’s *Order Approving Tariff and Agreement*, issued September 29, 2005, and subsequent *Order Regarding Status Reports*, issued April 3, 2007, the Staff is to file by September 15, 2008, its quarterly status report regarding Mill Creek Sewers, Inc., (“Mill Creek” or “Company”) with the Commission.

2. Also within the Commission’s *Order Regarding Status Reports* (“Order”) Staff was directed to file a notice “[i]f, at any time, changes are made regarding the operation or management of Mill Creek Sewers, Inc.” Order at page 3.

3. On or about August 29, 2008, as Staff was collecting information for its quarterly status report, Staff was informed that Mill Creek Sewers, Inc.'s manager resigned.

4. Since the owner does not run this company in a "hands on" fashion, the absence of a manager leaves the Company without an employee to perform day-to-day tasks with regard to bookkeeping and billing. The former manager was also the main person assisting Staff in accessing the Company’s billing, operations, and other records used by Staff to review and report on the status of the Company.

5. During the week of September 8, the Staff has assisted the Company's owner in getting current bills paid, and seeking someone who can do the billing and bookkeeping.

6. As the Company, presently, does not have a manager to take care of billing, bookkeeping and other operational issues and communicate with Staff about these items, it is difficult for Staff to access and analyze the Company's books and records in preparation of Staff's status report on the Company's financial condition.

7. Staff respectfully requests an extension to file its quarterly status report from September 15 to September 30, 2008, for Staff to be able to assess and report the status and progress of the Company to the Commission.

**WHEREFORE**, the Staff submits this notice and respectfully requests the Commission grant Staff an extension to file its quarterly status report regarding Mill Creek Sewer, Inc., to September 30, 2008.
