ORDER GRANTING INTERVENTION AND DIRECTING FILING

On October 12, 2001 Southwestern Bell Telephone Company, Southwestern Bell Texas, Inc., and Southwestern Bell Telephone L.P. d/b/a Southwestern Bell Telephone Company filed a pleading requesting that the Commission approve a corporate restructuring and stock transfer. In response to a Commission order, the parties filed preliminary briefs. The Commission will benefit from a further discussion of the difference in the Commission's jurisdiction over SWBT as a Texas limited partnership compared to the jurisdiction it currently has over SWBT as a Missouri corporation.
