REPLY TO STAFF RECOMMENDATION

Comes Now WorldCom, Inc. ("WorldCom"), by its undersigned counsel, and on behalf of its subsidiary Missouri competitive telecommunications companies identified in the Application filed herein, pursuant to 4 CSR 240-2.080(15) files its Reply to Staff Recommendation.

WorldCom appreciates Staff's favorable recommendation and hopes that the Commission will be able to take prompt action and approve the proposed reorganization. As Staff indicates, the Bankruptcy Court has now approved the Plan of Reorganization, so it will be in the public interest to implement all aspects of the Plan - including the reorganization - as soon as possible.

In abundance of caution, and strictly to avoid the possibility of confusion, WorldCom offers a clarification to Staff's summary of the proposed reorganization. Only the CLEC assets and operations of MCI WorldCom Communications, Inc. will be transferred to MCImetro. MCI WorldCom Communications will remain an IXC. The Staff Memorandum accurately describes these transactions, but the Recommendation itself is not quite as specific and could be misinterpreted.

WHEREFORE, WorldCom requests the Commission to accept this Reply and expeditiously proceed to grant the relief requested in the Application, in accordance with the Stipulation.
