**MOTION FOR EXTENSION OF TIME**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and submits its *Motion for Extension of Time* as follows:

1. On September 21, 2009, Timber Creek Sewer Company (Timber Creek or Applicant) filed an *Application* with the Missouri Public Service Commission (Commission) seeking permission, approval, and a certificate of convenience and necessity authorizing Applicant to install, acquire, build, construct, own, operate, control, manage, maintain and extend a sewer system for the public within the proposed service area in Clinton County, Missouri.

2. On September 22, 2009, the Commission filed *Notice of Application, and Order Setting Deadline for Intervention and Directing Staff to File Recommendation*. The deadline for invention was October 13, 2009. Staff was ordered to file a recommendation no later than October 20, 2009.

3. Staff plans on conducting an onsite visit, which has not yet occurred, that is necessary to gather additional facts.

4. Staff will need sufficient time to make the visit, obtain the facts, and review them to make a proper recommendation to the Commission. Therefore, Staff cannot make a recommendation by October 20, 2009.

**WHEREFORE**, because the Staff Recommendation date is October 20, 2009, Staff needs sufficient time to review the additional facts obtained from the onsite visit, Staff moves that the Commission grant an extension of Staff's recommendation deadline until November 13, 2009.
