STAFF’S AMENDED COMPLIANCE TARIFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission, through counsel, and submits this *Staff’s Amended Compliance Tariff Recommendation*.

1. On October 24, 2019 Staff filed *Staff’s Compliance Tariff Recommendation* in response to the Commission’s October 15, 2019 *Order Directing Staff to File Statement Concerning Timber Creek’s Compliance Filing*.

2. Staff inadvertently did not include in its October 24, 2019 filing 1st Revised Sheets 2B and 3B, which Timber Creek Sewer Company filed October 14, 2019. Staff’s October 24, 2019 filing includes only the substitute revised tariff sheets Timber Creek filed October 18, 2019 (2nd Revised Sheet No. 1, 1st Revised Sheet No. 2A, and 1st Revised Sheet No. 3A).¹

3. Staff reviewed the revised and substituted tariff sheets and concludes that 1st Revised Sheet No. 2B and 1st Revised Sheet No. 3B Timber Creek filed October 14, 2019 and the 2nd Revised Sheet No. 1, 1st Revised Sheet No. 2A, and 1st Revised Sheet No. 3A Timber Creek filed October 18, 2019 comply with the Commission’s

September 11, 2019 *Order Granting Certificate of Convenience and Necessity*. Thus, Staff recommends approval of:

- 2nd Revised Sheet No. 1 canceling 1st Revised Sheet No. 1
- 1st Revised Sheet No. 2A canceling Original Sheet No. 2A
- 1st Revised Sheet No. 3A canceling Original Sheet No. 3A
- 1st Revised Sheet No. 2B canceling Original Sheet No. 2B
- 1st Revised Sheet No. 3B canceling Original Sheet No. 3B

WHEREFORE, Staff prays that the Commission will accept this Recommendation, and issue an order approving Timber Creek's proposed tariff sheets filed October 14 and October 18, 2019, allowing them to take effect November 13, 2019; and grant such other and further relief as the Commission deems just in the circumstances.
