PROPOSED FILING DATE

COMES NOW, the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its *Proposed Filing Date*, states as follows:

1. On July 23, 2021, Elm Hills Utility Operating Company, Inc. (“Elm Hills”) filed its *Application and Motion for Waiver (“Application”)* with the Missouri Public Service Commission requesting that the Commission grant it a Certificate of Convenience and Necessity authorizing it to install, acquire, build, construct, own, operate, control, manage, and maintain a sewer systems in an area of Johnson County, Missouri.

2. On that same day, the Commission issued its *Order Directing Notice, Setting Date for Intervention, and Directing Staff to File a Pleading (“Order”)*. The *Order* directed Staff to file a pleading indicating when it can file a recommendation no later than August 6, 2021.

3. It is Staff’s belief at this time that it can file recommendation on Elm Hills’ *Application* no later than September 20, 2021.

WHEREFORE, Staff respectfully requests that the Commission issue an order directing its Staff to file a recommendation regarding Elm Hills’ *Application* no later than September 20, 2021; and such other and further relief as the Commission deems just in these circumstances.
