**STAFF RECOMMENDATION ON COMPLIANCE TARIFF**

Staff of the Missouri Public Service Commission files the following *Recommendation* to approve or allow to go into effect by operation of law Tariff YS-2022-0073 filed by Mid Mo Sanitation, LLC (Mid-MO) on October 7, 2021:

1. Mid-MO's tariff revision responds to the Commission's September 29, 2021, order requiring Mid-MO to submit newly created and/or revised tariff sheets to include an updated map and legal description to reflect its authority to operate its sewer system in the land application area for which the Order granted a certificate of convenience and necessity. Mid-MO's tariff contains an effective date of November 6, 2021.

2. The Commission's order granted Mid-MO a CCN "authorizing it to operate, maintain, control, and manage the portion of its sewer system outside of its currently existing service area to include the land application area set out in Attachments A and B of Staff's Memorandum attached to Staff's Recommendation."<sup>1</sup>

3. Staff has reviewed Mid-MO's tariff and concluded that it includes an accurate updated map and legal description to include the land application area set out in Attachments A and B of Staff's Memorandum.

4. Accordingly, Staff recommends the Commission issue an order approving or in the alternative a notice allowing the following tariff to take effect:

5. Staff attaches and incorporates the Affidavit of Andrew Harris in support of this Recommendation.

**WHEREFORE**, Staff respectfully asks the Commission to accept Staff's *Recommendation* and to issue an order approving Mid-MO's tariff or a notice that Mid-MO's tariff will be allowed to go into effect by operation of law on November 6, 2021; and for such other and further relief the Commission considers just.


