STAFF'S COMPLIANCE TARIFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff), through counsel, and recommends that the Commission approve the tariff sheets Confluence Rivers Utility Operating Company, Inc. (Confluence) filed on May 3, 2023 (Tracking Number YS-2023-0195) and May 12, 2023 (Tracking Number YS-2023-0203).

On March 22, 2023¹ (effective on April 21), the Commission issued an order granting Confluence's application to acquire the sewer system assets (the "Oasis System") of Oasis MHP LLC (Oasis), a mobile home park in Cass County, Missouri. The Commission also authorized a certificate of convenience and necessity for Confluence to provide sewer service, subject to certain conditions set out in the order. Among those conditions was that Confluence would revise P.S.C. MO No. 21 for the addition of the Oasis System, to become effective before closing on the asset, by filing tariff sheets for the service area map, service area written description for the Oasis system, and a revised table of contents.

On May 3, Confluence filed Tariff Revision (YS-2023-0195) with a Motion for Expedited Treatment, and on May 12, Confluence filed Tariff Revision (YS-2023-0203) with a Second Motion for Expedited Treatment. On May 3, the Commission issued its
