# ORDER GRANTING LEAVE TO AMEND AND DIRECTING A FURTHER STAFF RECOMMENDATION

On January 4, 2023,<sup>1</sup> Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application regarding the acquisition of an unpermitted sewer system. The Staff of the Commission (Staff) filed an initial recommendation on April 6. Pertinent here, Staff's initial recommendation advised of deficiencies in the application of Confluence Rivers, anticipated an amended application, and requested 45 days to review the anticipated amended application if it should be filed.

On April 18, Confluence Rivers and the Receiver jointly requested leave to amend its application. To that end, Confluence Rivers and the Receiver jointly filed an amendment to the Joint Application. The Commission finds the request to amend the application reasonable and will grant it.

The Commission will also direct its Staff to review the amendment and provide an updated or supplemental recommendation.
