On June 2, 2021, the Commission issued its *Order Granting Certificate of Convenience and Necessity*, authorizing Missouri-American Water Company (MAWC) to install, own, acquire, construct, operate, manage, and maintain a sewer system in and around Taos, Missouri, in the area served by the City of Taos, Missouri (Taos System). The Commission's order directed MAWC to submit tariff filings for the Taos System.

On June 30, 2021, MAWC filed tariff sheets, assigned Tariff No. JS-2021-0267. The tariff sheets bear a proposed effective date of July 30, 2021.

The Commission will order the Staff of the Commission to file a recommendation regarding whether the tariff sheets, assigned Tariff No. JS-2021-0267, comply with the Commission's June 2, 2021 order and should otherwise be approved. To facilitate timely review, the Commission will establish a deadline for any response to Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation on the tariff sheets, assigned Tariff No. JS-2021-0267, no later than July 12, 2021.

2. Any response to Staff's recommendation shall be filed no later than July 15, 2021.

3. This order shall be effective when issued.
