STAFF COMPLIANCE TARIFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and hereby submits this *Staff Compliance Tariff Recommendation*.

1. On June 2, 2021, the Commission issued its *Order Granting Certificate of Convenience and Necessity*, authorizing Missouri-American Water Company (“MAWC”) to install, own, acquire, construct, operate, manage, and maintain a sewer system in and around Taos, Missouri, in the area served by the City of Taos, Missouri (“Taos System”).

2. On June 30, 2021, MAWC filed tariff sheets, assigned Tariff No. JS-2021-0267, bearing a proposed effective date of July 30, 2021. Subsequently, on July 1, 2021, the Commission issued its *Order Directing Filing*, ordering Staff to file a recommendation regarding whether the tariff sheets comply with the Commission’s June 2, 2021, order and should otherwise be approved, no later than July 12, 2021.

3. After review, Staff concludes that the filed tariff sheets, assigned Tariff No. JS-2021-0267, comply with the Commission’s June 2, 2021, *Order Granting Certificate of Convenience and Necessity*. Thus, Staff recommends approval of:

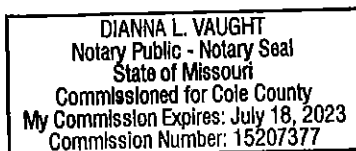


