The Commission will grant the Office of the Public Counsel's request for a local public hearing.

THE COMMISSION ORDERS THAT:

1. The Commission gives notice that it shall hold a local public hearing on January 26, 2010, beginning at 6:00 p.m. A question-and-answer session will be held before the hearing beginning at 5:30 p.m.

2. The local public hearing shall be held in the City of Osage Beach City Hall, located at 1000 City Parkway, Osage Beach, Missouri 65065.

3. No later than January 4, 2010, Lake Region Water & Sewer Company shall mail notice of this hearing consistent with this order, said notice being approved by the parties before it is mailed.

4. Customers wishing to make written comments or secure additional information may contact the Office of the Public Counsel, Post Office Box 2230, Jefferson City, Missouri 65102, telephone (573) 751-4857. Comments may also be registered in this case using the Commission's Electronic Information and Filing System at <http://psces/mpsc/>.

5. The local public hearing shall be held in a facility that meets the accessibility requirements of the Americans with Disabilities Act. 6. The Data Center of the Missouri Public Service Commission shall serve a copy of this order upon the County Commissions of Camden and Miller Counties, Missouri.

The Public Information Office of the Missouri Public Service Commission shall make notice of this order available to members of the General Assembly representing the residents in the service area of Lake Region Water & Sewer Company, and to the news media serving the residents of that service area.

8. This order shall become effective immediately upon issuance.
