SUSPENSION ORDER

On October 15, 1981, Union Electric Company of St. Louis, Missouri
submitted to this Commission tariffs to comply with
4 CSR 240-20.060 (cogeneration) for customers in the Missouri service area of
the company. The proposed tariffs have a requested effective date of
December 15, 1981.

To allow sufficient time to study the tariffs and the regulations
and to determine if they are just, reasonable and in the interest of the
public, it is the opinion of the Commission the proposed tariffs should be
suspended for a period of one hundred twenty (120) days beyond December 15,
1981, the requested effective date, unless otherwise ordered by this
Commission.

It is, therefore,

ORDERED: 1. That all tariff sheets submitted on October 15, 1981
by Union Electric Company of St. Louis, Missouri, for compliance with 4 CSR
240-20.060 for customers in the Missouri service area of the company, be and
the same are, hereby suspended for a period of one hundred twenty (120) days
beyond December 15, 1981, the requested effective date, to April 14, 1982,
unless otherwise ordered by this Commission.

ORDERED: 2. That this Order shall become effective on the date
hereof.


