JOINT REQUEST FOR LOCAL PUBLIC HEARING

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and on behalf of S.K. & M. Water and Sewer Company ("SK&M") and the Office of Public Counsel ("OPC"), states the following:

- On November 27, 2018, SK&M initiated rate cases¹ with the 1. Missouri Public Service Commission ("Commission") in which it requested an increase of \$200,000 in its annual water system operating revenues and \$100,000 in its annual sewer system operating revenues.
- 2. On December 3, Staff filed a Motion to Consolidate the cases in the interests of administrative efficiency, and a Rate Case Timeline in each matter specifying due dates for the activities required by the Commission's Staff Assisted Rate Case Procedures.²
- 3. On December 6, the Commission approved Staff's *Motion to Consolidate*, and designated Case No. SR-2019-0157 as the lead case.
- 4. Pursuant to Commission Rule 4 CSR 240-10.075(7)(A), Staff's Rate Case Timeline included a local public hearing scheduled to occur no later than sixty days after the opening of the cases; on January 16, 2019. The parties to this matter agree that a
