On March 29, 2022, the Commission ordered that a local public hearing be held on April 21 in these two rate cases. On April 5, Staff filed an *Update Regarding Initial Customer Notice* in which it informed the Commission that, to the best of its knowledge, S. K. & M. Water and Sewer Company had not yet sent an initial customer notice to its customers as required by 20 CSR 4240-10.075(7)(A) and the *Order Setting Local Public Hearing* issued on March 29, 2022.

The Commission will order Staff to file a report as to the status of the required notice.

THE COMMISSION ORDERS THAT:

1. On Tuesday, April 12, 2022, Staff shall file a status report as to whether S. K. & M. Water and Sewer Company has sent initial customer notice to its customers as required by 20 CSR 4240-10.075(7)(A) and the Commission's order.
2. This order shall be effective when issued.
