1	PROCEEDINGS
2	JUDGE HATCHER: Let's go on the record.
3	Today is January 17th, 2019. The Missouri Public
4	Service Commission has set this time for a local
5	public hearing in Case No. SR-2019-0157, which is
6	captioned as in the matter of SK&M Water and Sewer
7	Company's application for increases in annual sewer
8	and water system operating revenues.
9	The Commission has scheduled this local
10	public hearing to give members of the public a
11	chance to comment about SK&M's application. The
12	Missouri Public Service Commission regulates the
13	rates charged by public utility companies in
14	Missouri to ensure that those rates are just and
15	reasonable. The Commission also regulates the
16	quality of service and safety of the operations of
17	public utilities.
18	The Commission is made up of five
19	commissioners. The commissioners are appointed by
20	the governor to fixed terms and confirmed by the
21	Senate. The commissioners employ a staff of
22	engineers, accountants, attorneys, financial
23	analysts, and other specialties in the field of
24	utility regulation.
25	My name is Charles Hatcher. I am the

- 1 regulatory law judge and will preside over this
- 2 hearing. With me today is Commissioner Maida
- 3 Coleman. This is an official hearing of the
- 4 Missouri Public Service Commission and the
- 5 statements and testimony of witnesses will be
- 6 recorded by the court reporter and must be given
- 7 under oath.
- 8 All of the commissioners will have the
- 9 opportunity to read all of the witnesses' remarks
- 10 and, additionally, I will brief the commissioners on
- 11 what was said here tonight. The commissioners value
- 12 your comments and the comments will become part of
- 13 the official record.
- 14 Are there any opening comments, Commissioner
- 15 Coleman?
- 16 COMMISSIONER COLEMAN: Yes, please.
- Good evening. I'm so glad to see so many
- 18 people here. I always appreciate the participation
- 19 of the customers of the systems that we five
- 20 commissioners regulate. Although I am the only
- 21 commissioner here tonight of the five, please be
- 22 assured that all commissioners will have an
- 23 opportunity to see the information and the comments
- 24 that have been made tonight. This is, as the judge
- 25 said, testimony that will go into the record.

1 I am born and raised in Sikeston, Missouri 2 and always happy to find an excuse to get close to 3 home and I will probably make a little side trip 4 down there. But I'm so glad you all are here and 5 I'm especially interested in your experience as far 6 as the service. Customer service is always 7 important to me, so I like to know your experiences 8 and certainly your comments regarding the case that 9 we are here to discuss. Again, thank you for being 10 here tonight. 11 JUDGE HATCHER: I will begin by asking 12 counsel to enter their appearance for the record. 13 Counsel for SK&M? Counsel for Commission staff? 14 MR. JOHNSON: Thank you, Judge. 15 Johnson appearing on behalf of the staff of the 16 Missouri Public Service Commission and I have 17 provided the court reporter with my contact information. 18 19 JUDGE HATCHER: Thank you. And Office 20 of Public Counsel? 21 MR. SMITH: Ryan Smith appearing for the 22 Office of Public Counsel. I'm senior counsel. My 23 contact info has been provided to the court 24 reporter. Thank you. 25 JUDGE HATCHER: Thank you. Are there

1 any intervenors or their attorneys here? 2 Thank you. The process here this evening is 3 that I'm going to call the names listed on the 4 sign-up sheet in the order they appear. When I call 5 your name, please come on down to the microphone. 6 will place you under oath and ask you to state and 7 spell your name and then you could offer your 8 comments to the Commission. 9 There is no specific time limit but please 10 try to keep your remarks to under five minutes so 11 that everyone has a chance to testify. And, also, 12 after you're done making your comments please do 13 remain at the podium as there may be follow-up 14 questions from the Commission or the parties. 15 The commissioners will not be able to answer 16 any of your questions today because they do need to 17 remain impartial until after all of the evidence is presented at an evidentiary hearing. The Commission 18 19 has not made any decisions yet in this case. 20 Commission is interested in your comments and will 21 use your comments to help make their decision. 22 If you have questions, please speak to 23 representatives of the company, the Commission 24 staff, or the Office of Public Counsel. My final 25 request is to please be polite and courteous to

- 1 everyone speaking here today and treat them as you
- 2 would like to be treated.
- 3 The first name on the list is Angela Swan.
- 4 Ms. Swan, please raise your right hand. Do
- 5 you solemnly swear or affirm that the testimony you
- 6 are about to give is the truth, the whole truth and
- 7 nothing but the truth?
- 8 MS. SWAN: I do.
- JUDGE HATCHER: Thank you. Please state
- 10 and spell your last name.
- MS. SWAN: My name is Angela Swan.
- 12 S-W-A-N. I represent the Shawnee Homeowners
- 13 Association.
- JUDGE HATCHER: Thank you and please
- 15 proceed.
- 16 MS. SWAN: Okay. I have a prepared
- 17 statement. My name is Angela Swan. I am president
- 18 of the Shawnee Homeowners Association. I represent
- 19 the current lot owners in the Whippoorwill and
- 20 Raintree subdivisions. Both subdivisions are served
- 21 by SK&M and receive water as well as sewer services.
- 22 As such they stand to be heavily impacted by the
- 23 proposed rate increases.
- Do you prefer that I have my back to the
- 25 audience? Do you mind if I turn?

1	COMMISSIONER COLEMAN: You're talking to
2	us.
3	MS. SWAN: Okay. Thank you.
4	COMMISSIONER COLEMAN: Thank you.
5	MS. SWAN: Thank you for that
6	clarification.
7	The Shawnee Homeowners Association opposes
8	the SK&M rate increase as proposed for following
9	reasons:
10	One, it's too much at one time. While we
11	recognize that improvements must be made and income
12	must be generated to keep any system in good working
13	order, the proposed water and sewer increases of 45
14	percent and 130 percent respectively, place too much
15	of a burden on the customers at one time.
16	Two, impact on perspective homebuyers. The
17	proposed rates are out of the average range of other
18	systems in the area. An example, City of Perryville
19	bills average 29.43 for water and 36.57 for sewer,
20	and as such will become a major deterrent for
21	perspective homebuyers and investors in our
22	subdivision.
23	Three, consideration must be made for the
24	average incomes in these subdivisions. The two
25	subdivisions are inhabited largely by families in

the factory or truck driving profession, in addition 1 2 to several retired couples. Any change in the cost of living can be significant for households in these 3 4 income categories. A 45 to 130 percent increase in 5 these monthly bills will place an undue burden on 6 many households which are already strapped for 7 disposable income and/or living on fixed retirement 8 income. 9 Four, effect on new developments. 10 investors have already begun projects in our 11 subdivisions to address the housing shortage in our 12 Average rent for these units is generally in 13 the 550 to \$700 range. At this rate, renters in our 14 area can expect a utility bill to add 17 and a half 15 to 24 and a half percent to their base cost of rent. 16 If these new rates go through commuting from 17 outside areas could continue to be a better option 18 for most stymieing demand for the new units. 19 Five, improvements should be phased in. 20 Regulations for water and sewer utilities are 21 tightening and improvements surely will be necessary 22 for SK&M facilities. We ask that the Commission 23 review and prioritize improvement needs based on 24 which improvements are most urgent and which might 25 have alternative solutions to come up with a

1 phase-in plan for upgrading the system instead of 2 funding so many at once. 3 Six, projected growth and customer base for 4 SK&M. Ground has already been broken on two 5 development projects in our two subdivisions that 6 will add a projected total of 110 units to the SK&M 7 customer list for both water and sewer services. Ιf 8 completed as planned these developments will 9 increase monthly revenue for SK&M Water by 36 10 percent and sewer by 70 percent in the next few 11 years. 12 This is not just a proposed set of 13 blueprints. Developers have already begun to clear 14 the land and improve the roads for construction in 15 the spring of this year. Accepting our request to 16 approve a rate increase based on phased-in 17 improvements will give time for those building 18 developments to be completed and the cost to be 19 spread over more households. This is particularly 20 relevant in the sewer system, which is currently set 21 to count on generating a revenue increase of 22 \$100,000 spread over only 156 customers. 23 In conclusion, SK&M Water and Sewer has

provided reliable service for over 40 years. It is

designed to handle many more households that have

- 1 ever used it. Building projects have been very few
- 2 and far between in Whippoorwill and Raintree in the
- 3 last 20 years, but now the existence of a
- 4 well-established water and sewer system is emerging
- 5 as an attractive cost reduction for developers
- 6 seeking to address the proven need for more lower
- 7 and middle income housing in Perry County.
- 8 We support investments to the system for
- 9 current and future use and respectively request that
- 10 any rate increase be considered based on a plan to
- 11 phase-in projects while avoiding placing the undue
- 12 burden of a sudden and significant increase on the
- 13 already cashed-strapped households that SK&M serves.
- 14 Thank you.
- 15 JUDGE HATCHER: Thank you, Ms. Swan. If
- 16 you could stay there for just a second.
- MS. SWAN: Sure.
- 18 JUDGE HATCHER: Any questions from the
- 19 bench?
- 20 COMMISSIONER COLEMAN: No. Thank you,
- 21 Ms. Swan.
- JUDGE HATCHER: Any questions from
- 23 counsel?
- MR. JOHNSON: Thank you for your
- 25 testimony.

1 JUDGE HATCHER: Thank you. You are 2 dismissed, Ms. Swan. 3 Laura Manche. I do apologize if I'm 4 mispronouncing your last name. 5 MS. MANCHE: Manche. 6 JUDGE HATCHER: Thank you. 7 Ms. Manche, please raise your right hand. 8 you solemnly swear or affirm that the testimony you 9 are about to give is the truth, the whole truth and nothing but the truth? 10 11 MS. MANCHE: I do. 12 Thank you. And please JUDGE HATCHER: 13 state your name and spell your last name. 14 MS. MANCHE: Laura Manche. M-A-N-C-H-E. 15 JUDGE HATCHER: And please proceed with 16 your comments. 17 MS. MANCHE: Well, I am speaking on 18 behalf of one of those cash-strapped families. Over 19 the last many years I have raised four children, me 20 and my husband, three of which have been special 21 Now three of those children have moved out. 22 The two with special needs that have moved out are 23 doing very well, have become very productive adults. 24 We are very proud of them. 25 We have one son living with us yet. He's 15

- 1 years old. For anybody to look at him he's a
- 2 normal, healthy 15-year-old. In reality he has a
- 3 blood condition that is \$1200 a month to keep him
- 4 alive.
- Now, over the years as the kids have moved
- 6 out finances have gotten slightly better. The last
- 7 couple of years we've actually been able to do a
- 8 couple of things. Other than that it has been
- 9 staring at the four walls with our kids, work, and
- 10 that's about it.
- So you put a \$1200 a month just for him,
- 12 that's not including the medical expenses for me and
- 13 my husband, we are looking at a possible four
- 14 surgeries in the next year to two years, and then
- 15 you have our electric bill, of course the water
- 16 bill, sewer bill, any TV, phone, whatever, so you're
- 17 asking us to possibly pay double or triple our
- 18 normal water bill. We can't do it.
- The previous owners worked with us. Do we
- 20 know whether or not the new owners will, we don't
- 21 know. But from the sounds of it they don't have the
- 22 ability to. We understand that the facilities do
- 23 need upgraded. That's not a problem. But to up our
- 24 bills that quickly, that much is ludicrous,
- 25 ridiculous, and it needs to be done over time to

- 1 where we can adjust our income the way it needs to
- 2 be adjusted so that we can actually hopefully afford
- 3 bills.
- JUDGE HATCHER: Thank you very much, Ms.
- 5 Manche.
- Are there any questions?
- 7 COMMISSIONER COLEMAN: No. Thank you,
- 8 Ms. Manche.
- JUDGE HATCHER: Thank you, Ms. Manche.
- 10 You are dismissed.
- Doris Rehkop? How was the pronunciation on
- 12 that one?
- MS. REHKOP: Great.
- JUDGE HATCHER: Thank you.
- 15 Please raise your right hand. Do you
- 16 solemnly swear or affirm that the testimony you are
- 17 about to give is the truth, the whole truth and
- 18 nothing but the truth?
- MS. REHKOP: I do.
- JUDGE HATCHER: Thank you. And please
- 21 state your name and spell your last name.
- MS. REHKOP: Doris Rehkop. R-E-H-K-O-P.
- JUDGE HATCHER: And Ms. Rehkop, please
- 24 proceed with your comments.
- MS. REHKOP: My only comment is I am

- 1 retired and I don't have a problem with rate
- 2 increases. I think the problem is he did not check
- 3 out everything before he went into this. I live on
- 4 a fixed income and you're going to put this into my
- 5 budget and it's going to cause hardship for me and
- 6 my husband to live there.
- We can't do anything with the property until
- 8 this is resolved and our septic system is having
- 9 some issues and if we can't get it resolved then
- 10 we're stuck. So I feel that a compromise needs to
- 11 come about before we can go forward. That's all I
- 12 have.
- JUDGE HATCHER: Thank you, Ms. Rehkop.
- 14 Any questions?
- 15 COMMISSIONER COLEMAN: No.
- 16 JUDGE HATCHER: Thank you, Ms. Rehkop.
- 17 You are dismissed.
- 18 Jim Robertson?
- Mr. Robertson, did I have your name right?
- 20 MR. ROBERTSON: My name is Jim
- 21 Robertson.
- JUDGE HATCHER: Thank you.
- 23 Mr. Robertson, if you would please raise your
- 24 right hand. Do you solemnly swear or affirm that
- 25 the testimony you are about to give is the truth,

1 the whole truth and nothing but the truth? 2 MR. ROBERTSON: Absolutely. 3 JUDGE HATCHER: Thank you. Please state 4 your name and spell your last name, sir. 5 MR. ROBERTSON: My first name is Jim. Last name is Robertson. R-O-B-E-R-T-S-O-N. 6 7 JUDGE HATCHER: Thank you. 8 MR. ROBERTSON: The only thing I've got 9 is as a homeowner I would like to know where my 10 responsibilities begin and end as far as sewer line 11 goes? 12 JUDGE HATCHER: There will be some staff 13 available after the meeting that might be able to 14 answer that question a little better for you. 15 MR. ROBERTSON: Okay. The only thing 16 I've got is the last part of October of last year I 17 had a sewer backup in my basement. I called Mr. 18 LaRose. I said, "I've got a sewer back up in my 19 basement." He said, "Well, I don't have a 20 Roto-Rooter." He said, "You need to call somebody." 21 Next day I call Schumer Brothers, they come 22 right out. Going through my neighbor's property, 23 went through there, he put about 75 feet of -- what 24 do you call it -- a snake, down through there, all 25 of a sudden, Oh, we're clean. I got a bill, \$220

1 and some-odd cents. 2 I called Mr. LaRose and said, I got this 3 bill." He said, "Well, I quess you want me to pay 4 it." I said, "You're the owner of the sewer line." 5 A couple days later I told my wife, I said, 6 "I'm going to go ahead and pay this bill to keep my 7 credit in good standing." 8 I sent him a copy of the bill. That was 9 October of last year. I have yet to get reimbursed. 10 I'm not asking the Commission to reimburse me. 11 what is right is right and what's wrong is wrong. 12 Simple as that. That's the way I was raised. 13 That's all I have. 14 JUDGE HATCHER: Thank you, 15 Mr. Robertson. Hold on just a minute. 16 MR. ROBERTSON: Thank you very much. 17 JUDGE HATCHER: If you could stay right 18 there, Mr. Robertson. Questions? 19 COMMISSIONER COLEMAN: Mr. Robertson, 20 good evening. So tell me what type of response you 21 got from the company after you paid the bill? You 22 said --23 MR. ROBERTSON: None. 24 COMMISSIONER COLEMAN: -- this was in

October?

1	MR. ROBERTSON: None.
2	COMMISSIONER COLEMAN: So you sent them
3	the bill, there has been no response?
4	MR. ROBERTSON: Yes, ma'am.
5	COMMISSIONER COLEMAN: Okay. So I would
6	like you to have a conversation with the Public
7	Service Commission staff at the conclusion of this
8	hearing because we do have the capability to reach
9	out to the company to help you settle this
10	situation, okay?
11	MR. ROBERTSON: I appreciate it.
12	COMMISSIONER COLEMAN: Thank you, sir.
13	MR. ROBERTSON: Thank you very much.
14	COMMISSIONER COLEMAN: Thank you.
15	JUDGE HATCHER: Thank you,
16	Mr. Robertson.
17	Patrick Naeger?
18	Mr. Naeger, did I have that pronunciation
19	correct?
20	MR. NAEGER: You did it superbly.
21	JUDGE HATCHER: Thank you.
22	MR. NAEGER: Judge, good evening
23	JUDGE HATCHER: Wait. Wait. Mr.
24	Naeger, I've got to swear you in first. Thank you.
25	Do you solemnly swear or affirm that the

- 1 testimony you are about to give is the truth, the
- 2 whole truth and nothing but the truth?
- 3 MR. NAEGER: I do.
- 4 JUDGE HATCHER: Thank you. If you would
- 5 state your name and spell your last name and then
- 6 proceed with your statement.
- 7 MR. NAEGER: Patrick Naeger.
- $8 \quad N-A-E-G-E-R$.
- 9 Judge Hatcher and Commissioner Coleman, thank
- 10 you for coming to Perry County. We welcome you here
- 11 and we appreciate the opportunity to have our voice
- 12 heard.
- In 2013 -- and I have submitted -- I'll be
- 14 brief because I have submitted written testimony to
- 15 the Commission. But in 2013 my wife and I, we
- 16 purchased a mobile home park that is serviced by
- 17 SK&M. Our mobile home park Parkwood Village, LLC.
- 18 On our property we have 50-plus units being serviced
- 19 by SK&M currently and looking to expand our park as
- 20 the demand for affordable housing in Perry County is
- 21 pretty significant.
- 22 For the most part we have had good service,
- and few problems with the old owner or for that
- 24 matter the new owner alike. While the new owners
- 25 have not owned the service for very long I

- 1 personally know Rod and Susan LaRose and hold them
- 2 in high regard.
- 3 Unfortunately, many of our tenants struggle
- 4 month to month and live paycheck to paycheck. While
- 5 I understand that the new owners want to invest in
- 6 their business, however the increases they are
- 7 asking for seem extremely excessive and put the
- 8 investment in their business on the backs of
- 9 customers who do not have any other service options
- 10 available.
- Because prior some spoke of possibly putting
- in their own well, drilling their own well or
- 13 putting in their own septic system. Well, in my
- 14 trailer park I don't have an option. This is the
- only option I have to service my tenants.
- 16 Furthermore, the increases that are proposed
- 17 for just the tenants I represent are going to be in
- 18 excess of \$40,000 annually.
- In closing, I want to say this, I am not
- 20 against SK&M. I am not against an increase. But I
- 21 am against anything that is unreasonable and unfair.
- 22 I think most in this room will work very, very hard
- 23 to find a solution and I think all of us want to
- 24 find a solution. But obviously that is why this
- 25 rate increase is before the Commission and I trust

that the Commission will do its job, that the 1 2 counsel will represent those of us and that's why we have a Public Service Commission to solve these 3 4 kinds of problems and I trust that you will do that. And we hope to see and hear more information 5 6 and be further engaged and appreciate you making the 7 trip to Perry County. Thank you. 8 JUDGE HATCHER: Thank you, Mr. Naeger. 9 Any questions? 10 COMMISSIONER COLEMAN: I always have 11 questions. 12 Okay. So Mr. Naeger, so I understand, based 13 on what you said, that this is a mobile park that 14 these are tenants? 15 MR. NAEGER: Yes, ma'am. 16 COMMISSIONER COLEMAN: So you charge 17 rent? 18 MR. NAEGER: Yes, ma'am. 19 COMMISSIONER COLEMAN: So as a result of 20 the increase, since you pay the water bill -- did I 21 get that right? 22 MR. NAEGER: No, ma'am. 23 COMMISSIONER COLEMAN: So the water 24 bill, the sewer bill is paid by the actual residents of the homes? 25

1 MR. NAEGER: Yes. Most of my tenants, 2 Commissioner, they own their own mobile home and I 3 provide them the space. 4 COMMISSIONER COLEMAN: The land. Okay. 5 MR. NAEGER: Now, I do have 6 approximately 14 units that I own and I rent the 7 home out to them. But all the tenants are required 8 to pay their own water and their own sewer bill. 9 What is included in the lot rent, as well as 10 the rent that I charge for the unit separately, is 11 trash pick up and that's pretty much it. 12 COMMISSIONER COLEMAN: All right. 13 MR. NAEGER: But they are responsible 14 for their own water, sewer and electric. 15 COMMISSIONER COLEMAN: I wanted to get 16 an understanding because if they were paying rent to 17 you and you were paying the water bill and the sewer 18 bill that means you would be having to increase 19 their rent, so --20 MR. NAEGER: Either way that becomes my 21 challenge as a landlord. 22 COMMISSIONER COLEMAN: Sure. 23 MR. NAEGER: And one of my tenants spoke 24 up earlier, that, you know, you increase somebody's 25 water and sewer by a substantial rate and charge

- 1 them 120 to \$130 a month -- I mean, the pad rent
- 2 that I charge for somebody to live in my park and
- 3 have access to the property and everything is only
- 4 \$125 a month. So they would be paying as much or
- 5 more for their water and sewer as they would for the
- 6 occupancy in my park, which seems a little
- 7 excessive.
- 8 COMMISSIONER COLEMAN: Thank you for the
- 9 clarification. Thanks for coming.
- MR. NAEGER: Thank you.
- 11 JUDGE HATCHER: And Connie Cambron?
- Ma'am, did I get that pronunciation correct?
- MS. CAMBRON: Yes, sir.
- JUDGE HATCHER: Ms. Cambron, would you
- 15 please raise your right hand. Do you solemnly swear
- 16 or affirm that the testimony you are about to give
- is the truth, the whole truth and nothing but the
- 18 truth?
- MS. CAMBRON: Yes, sir.
- JUDGE HATCHER: Please state your name
- 21 and spell your last name.
- MS. CAMBRON: Connie Cambron.
- $23 \quad C-A-M-B-R-O-N$.
- JUDGE HATCHER: And please proceed with
- 25 your comment.

- 2 Mr. Naeger's tenants. I do own my own trailer and, like he said, with this rate increase I will have to 3 4 live with either not pay him or not pay my water 5 bill. Because, you know, as you get older we all 6 know our health kind of declines and you got to have 7 surgeries and more medicines, which sucks, but 8 nonetheless. I don't want to have to pick and 9 choose what I pay. I do that now. I do get behind 10 on the pad rent, Mr. Naeger works with me and we get 11 all caught up. 12 I have not paid my water bill yet this month. 13 I can't afford it. If I can't afford it now how am 14 I going to afford it when you all raise the rates?
- 15 I'll have to live without water. I'm not going to
- 16 put my three dogs through not having water. I'll
- 17 have to buy them bottled water. That's not being
- 18 fair to us. That's not being fair to anybody that
- 19 lives in the whole entire Shakertown area in my
- 20 opinion.

- To me, I am not against a new rate increase.
- 22 I'm really not. I understand the upkeep. I
- 23 understand -- you know, being a homeowner you got
- 24 upkeep. That's just the way it is. But I'm not
- 25 going to charge you for my upkeep. That's not being

- fair. You know, it's just -- I don't know.
- 2 He has already took away from my dogs. They
- 3 had their dog pen. They're well-behaved dogs. If a
- 4 stranger comes up, they will let you know. If
- 5 there's a strange vehicle out there, they will let
- 6 you know. If Mr. Naeger is out there after dark,
- 7 they will let you know.
- 8 And we had to downsize the pen because the
- 9 previous owner didn't have a problem with my dogs,
- 10 but Mr. LaRose says if you don't downsize it I'm
- 11 cutting you off forever and you'll never have water
- 12 again. That's not right either. We downsized the
- 13 dog yard. I have three rescue dogs. Their yard is
- 14 not big enough, especially when you got to mow it
- 15 and you got to water it.
- That's pretty much it. Raising the rates,
- 17 people like us cannot afford it. Ten or \$15, 20,
- 18 yes, but to triple it, no. I'll have to either sell
- 19 to Mr. Naeger and move out or just live without
- 20 water. I can't afford them both. That's it.
- JUDGE HATCHER: Thank you, Ms. Cambron.
- 22 COMMISSIONER COLEMAN: No questions.
- 23 Thank you.
- JUDGE HATCHER: That is the end of the
- 25 list of the sign-up testimony. Now I would like to

- 1 open it up to anyone that would like to come forward
- 2 that didn't sign the list and testify, otherwise --
- 3 please come forward, ma'am -- otherwise the hearing
- 4 will be over in the next few minutes.
- 5 MS. MUENCH: My name is Pamela Muench.
- 6 JUDGE HATCHER: If you could hold on
- 7 just a moment, Ms. Muench. Let me swear you in
- 8 first.
- 9 MS. MUENCH: Okay.
- JUDGE HATCHER: Do you solemnly swear or
- 11 affirm that the testimony you are about to give is
- 12 the truth, the whole truth and nothing but the
- 13 truth?
- MS. MUENCH: Yes.
- 15 JUDGE HATCHER: Thank you. Please state
- 16 your name and spell your last name.
- MS. MUENCH: Pamela Muench.
- $18 \quad M-U-E-N-C-H$.
- JUDGE HATCHER: And please go ahead and
- 20 proceed with your statement.
- 21 MS. MUENCH: I just wanted to bring up
- that we were planning on building up to 80
- 23 townhomes. We bought 10 acres of land and one of
- 24 the reasons that we picked this place, this area was
- 25 because it had sewer and water and we knew the

- 1 breaks were about 60 -- probably \$60 a month
- 2 average.
- 3 So we started -- we went to meetings and we
- 4 were assured that they could handle it. We went to
- 5 homeowner meetings, the homeowners association and
- 6 we had meetings and we asked, "Could this sewer
- 7 system assist us with 80 more units?" And we were
- 8 assured that, yes, we could. And we had no idea the
- 9 price was going to go up or try to go up double or
- 10 more.
- And so all I'm asking is since we were
- 12 planning on doing 80 units we were going to -- we
- were going to be kind of helping update the system.
- 14 We were going to be putting in new meters, running
- 15 new water lines, sewer lines, and they were going to
- 16 be getting the extra revenue from us.
- Now that this has happened I'm really, really
- 18 concerned that people can't afford to live in our
- 19 new places. We were planning on charging about 700
- 20 a month rent. We're not subsidized by the
- 21 government. And by the time they pay 700 a month
- 22 rent, 120 for water and sewer, they pay their
- 23 electric, it's a thousand dollars a month.
- And we have put our project on hold now
- 25 because of this. And we're waiting to see what's

1 going to happen. And we would like somehow that you 2 could just raise it up a little at a time, do a 3 little bit of the repairs as needed because with the 4 extra revenue of us and there's another subdivision 5 they're going to be building 30 houses -- we're 6 doing -- well, we were planning on starting at 40 7 townhomes in the first phase and then another 40. So that's 110 places that would really help and if 9 he could just repair what's needed at first, make priorities and raise it up \$20 a month so everybody 10 can afford that. Because the minimum would be \$123 11 12 a month by what it says in the paperwork. So I just 13 wanted you to take that into consideration. Okay. 14 JUDGE HATCHER: Thank you. I appreciate 15 that. 16 COMMISSIONER COLEMAN: Thank you. 17 JUDGE HATCHER: Are there any other persons who would like to come forward and testify? 18 19 Please come forward. Let me swear you in 20 first. Do you solemnly swear or affirm that the 21 testimony you are about to give is the truth, the 22 whole truth and nothing but the truth? 23 MS. BOXDORFER: Yes. 24 JUDGE HATCHER: And please state your 25 name and spell your last name for us.

MS. BOXDORFER: Alicia Boxdorfer. 1 2 B-O-X-D-O-R-F-E-R. 3 JUDGE HATCHER: Please go ahead. 4 MS. BOXDORFER: I would just like the 5 Commission to consider the fact that the new owners 6 of SK&M did not do due diligence when considering 7 buying this business and I feel that not all 8 businesses every year make profit and they should 9 have to eat some of the costs of these improvements 10 and all of the costs not be put on the customers in 11 such a way as other people spoke. Small increments 12 of increase. We should not be held completely 13 accountable because they did not do their due 14 diligence. 15 JUDGE HATCHER: Thank you. I appreciate 16 that. 17 COMMISSIONER COLEMAN: Thank you. 18 JUDGE HATCHER: Last call, anyone else 19 that would like to come forward and testify? All 20 right then. Any closing remarks from the 21 commissioners? 22 COMMISSIONER COLEMAN: No. Thank you. 23 JUDGE HATCHER: I would like to thank 24 all out of our participants tonight for their 25 testimony. If you do have any additional comments

- 1 or someone who could not be present would like to
- 2 comment you may make written comments by contacting
- 3 the Office of Public Counsel or by going to the
- 4 PSC's web page. And, again, staff will be
- 5 available -- PSC staff after the hearing.
- 6 Yes, sir?
- 7 AUDIENCE MEMBER: Filling out this paper
- 8 will do the same thing, that was handed back there?
- 9 The public comment form?
- 10 JUDGE HATCHER: Yes. Yes. That will
- 11 get to us and be able to be taken in as part of the
- 12 record.
- 13 All right. Once again there will be staff
- 14 here after the meeting if anyone has any other
- 15 questions.
- 16 MS. NEWCOM: Can I change my mind and
- 17 testify?
- 18 JUDGE HATCHER: Yes. Please come
- 19 forward. Let me swear you in first. I'm sorry.
- Do you solemnly swear or affirm that the
- 21 testimony you are about to give is the truth, the
- 22 whole truth and nothing but the truth?
- MS. NEWCOM: Yes.
- JUDGE HATCHER: Please state your name
- 25 and spell your last name, please.

- 1 MS. NEWCOM: My name is Marie Newcom.
- $2 \qquad N-E-W-C-O-M$.
- JUDGE HATCHER: And Ms. Newcom, please
- 4 go ahead.
- 5 MS. NEWCOM: In the past, and I have
- 6 lived in Shakertown for over 40 years, in the past
- 7 the City of Perryville has discussed annexing some
- 8 of the properties that SK&M services. And it seems
- 9 to me like if that is a possibility because the city
- 10 has extended their services out in B row (ph), which
- is where we are, if that's a possibility and perhaps
- 12 adding a lift station, that should be investigated
- 13 as an option before we go to all of this expense for
- 14 something that may not last 20 years or 10 years or
- 15 whatever. And it might be more feasible for the
- 16 people that live there to be able to afford it.
- 17 That's all.
- JUDGE HATCHER: Thank you, Ms. Newcom.
- 19 You're dismissed.
- 20 COMMISSIONER COLEMAN: Thank you.
- JUDGE HATCHER: Yes, please come
- 22 forward. Let me swear you in first, sir.
- 23 Do you solemnly swear or affirm that the
- 24 testimony you are about to give is the truth, the
- 25 whole truth and nothing but the truth?

1 MR. SCHAFROPH: Yes, sir. 2 JUDGE HATCHER: Please state your name 3 and spell your last name for us. 4 MR. SCHAFROPH: Gary Schafroph. 5 S-C-H-A-F-R-O-P-H. 6 My comment is regarding this paperwork they 7 Members of this audience just asked if handed out. these -- this comment sheet here would be accepted. 9 On the bottom of this page it says, "Please note 10 that the written comments may not be accepted as 11 evidence by the Commission. For that reason, public 12 comment is highly encouraged. The public who 13 testify on the record regarding the proposed rate 14 increase (sic)." 15 They say this paper you filled out or asked about may be, but at the bottom, that little fine 16 17 print down there says they don't have to accept it. 18 Thank you. 19 JUDGE HATCHER: Can you tell me who that 20 paper is from, sir? 21 MR. SMITH: Judge, that is from our 22 In the past Commission has denied 23 admittance of public comments into the record, so 24 that is why that footnote is there. 25 MR. HATCHER: Would that be because

1 perhaps it's eligible? 2 MR. SMITH: No. 3 JUDGE HATCHER: Could you explain a 4 little further? Can you all hear him? 5 COMMISSIONER COLEMAN: Can you go up to 6 the microphone? 7 MR. SMITH: Yeah, we have that comment there because in past cases, not in every case, but 9 the Commission in some cases has not allowed some written comments to be admitted into the record. 10 11 That doesn't happen in every case. - 1 I've been a commissioner for three and a half years

- 22 record all commissioners will have an opportunity to
- 23 hear your testimony.
- MR. SCHAFROPH: That's why I'm here, is
- 25 because more than one person from this audience

- 1 stated -- asked if this would go on record and we
- 2 were told when we walked in the door you could. But
- 3 the writing come from that office says it may or may
- 4 not, so if you want to say anything, if you want to
- 5 be on record, you might want to come up here and say
- 6 it now. They may not take your paper.
- 7 COMMISSIONER COLEMAN: Well, one thing
- 8 for sure, if you testify it's on the record. All
- 9 right. Thank you, sir.
- 10 JUDGE HATCHER: And I'm the judge in the
- 11 case, so I'll make sure that anything you do submit
- in writing is admitted into the record. I do
- 13 apologize for any confusion. I do want to make sure
- 14 and give everyone the opportunity if you would like
- 15 to come forward and testify. We do have a court
- 16 reporter here. Like we said, I'll swear you in and
- 17 you feel free to say anything you'd like even if
- it's just I agree with what someone else said.
- 19 Please raise your right hand. Do you
- 20 solemnly swear or affirm that the testimony you are
- 21 about to give is the truth, the whole truth and
- 22 nothing but the truth?
- MR. LAPPE: I do.
- JUDGE HATCHER: Please state your name
- 25 and spell your last name for us.

1	MR. LAPPE: Danny Lappe. L-A-P-P-E.
2	JUDGE HATCHER: Mr. Lappe, please go
3	ahead.
4	MR. LAPPE: I just want to make a
5	comment that in the literature that we were handed
6	that it says that with this increase their extra
7	revenues per year is \$300,000 in excess of that.
8	What I want to get noted is what is our assurance
9	that this money is going back into the sewer and the
10	water services and not just in somebody's pocket?
11	Because obviously somebody didn't do their
12	home work on this. They obviously paid too much for
13	a facility that needed lots of repairs. So as
14	concerned citizens we need to know make sure that
15	we're getting you know, we're putting money into
16	this, that we're going to get services back out of
17	that. Thank you very much.
18	JUDGE HATCHER: Thank you. Would anyone
19	else like to testify? Last call. I'm going to read
20	the last sentence on my script and then we're going
21	to close the hearing. Would anyone like to testify?
22	All right. Thank you all for coming. One
23	last reminder, staff will be available after the
24	hearing if you have any other questions.
25	Mr. Robertson, specifically, I know you
